#### 1. OVERVIEW

- **1.1.** *Purpose.* Through this Request for Proposal (RFP) the Agency of Commerce and Community Development, Department of Tourism and Marketing (hereinafter the "State") seeks one or more organizations to develop a series of skill building workshops for current or potential employees in outdoor recreation jobs in Vermont, including but not limited to, trail builders, bicycle mechanics and snow sports technicians.
- 1.2. Background. The outdoor recreation industry is facing some of the same workforce challenges as other sectors in Vermont, but even more acutely due to the disruption and increased demand for outdoor recreation services following the Covid pandemic, as well as inflation-fueled increased costs for employers and additional stresses from recent severe weather events. The Bureau of Economic Analysis has estimated that outdoor recreation supported 4.5% of Vermont's GDP in 2022, representing the third straight year of increase, up from 4.1% from 2021 and 3.7% in 2020. Vermont now ranks second in the country for the percentage of GDP from outdoor recreation, but in order to successfully support this sector, as well as serve the 13 million visitors that come to Vermont each year, many for our world-class recreation opportunities, we need to invest in a talent pipeline of well-trained, career-oriented individuals to work in Vermont's outdoor recreation industry.
- **1.3.** Contract Period. Contracts arising from this RFP will be for a period of **12 months** with an option to renew for up to two additional twelve-month periods. The State anticipates the start date will be September 1, 2024.
- **1.4. State's Single Point of Contact.** All communications concerning this RFP are to be addressed in writing to the State Contact listed on the front page of this RFP. Actual or attempted contact with any other individual from the State concerning this RFP is strictly prohibited and may result in disqualification.
- **1.5.** *Bidder's Conference.* A bidders' conference will not be held.
- 1.6. Question and Answer Period. Any vendor requiring clarification of any section of this RFP or wishing to comment on any requirement of the RFP must submit specific questions in writing no later than the deadline for question indicated on the first page of this RFP. Questions may be e-mailed to the point of contact on the front page of this RFP. Questions or comments not raised in writing on or before the last day of the question period are thereafter waived. At the close of the question period a copy of all questions or comments and the State's responses will be posted on the State's web site <a href="https://accd.vermont.gov/about-us/bidding-opportunities">https://accd.vermont.gov/about-us/bidding-opportunities</a>. Every effort will be made to post this information as soon as possible after the question period ends, contingent on the number and complexity of the questions.
- **1.7.** *Changes to this RFP.* Any modifications to this RFP will be made in writing by the State through the issuance of an Addendum to this RFP and posted online at <a href="https://accd.vermont.gov/about-us/bidding-opportunities">https://accd.vermont.gov/about-us/bidding-opportunities</a>. Verbal instructions or written instructions from any other source are not to be considered.
- **1.8. Source of Funds.** This project is being funded in whole or in part using federal monies. If a bidder requires assistance in preparing their proposal, registering with SAM.gov or needs guidance on socioeconomic certifications, the bidder may contact the Agency of Commerce & Community Development (ACCD), Department of Economic Development (DED), APEX

Accelerator. The Vermont APEX Accelerator (formerly the Procurement Technical Assistance Center (PTAC)) specializes in helping small businesses navigate the documentation associated with State and Federal procurement. There is no cost to the Contractor for assistance provided by APEX Accelerator. #### 2. SCOPE OF WORK

- 2.1. Scope of Services. The State seeks proposals from one or more organizations to develop a series of skill building workshops for current or potential employees in outdoor recreation jobs in Vermont, including but not limited to, trail builders, bicycle mechanics and snow sports technicians. Proposals that include a formal mechanism to recognize the training completed (e.g. in the form of a certificate or other transferable qualification) are preferred. Funds must be expended by August 30, 2025, and there is currently no funding available for the on-going operations for such workshops.
- **2.2.** *Program Elements.* Proposals will need to explain how the proposed skill building workshops will address and/or include the following elements:
  - **2.2.1.** Curriculum development
  - **2.2.2.** A learning framework, either through in-person classes or online instruction
  - **2.2.3.** Training or required expertise for instructors
  - **2.2.4.** Opportunities for hands-on experience and instruction
  - **2.2.5.** Marketing the available training program to potential participants
  - **2.2.6.** Mechanism to document participation and skills/education attained
- **2.3. Program Delivery.** Proposals will need to explain how the proposed skill building workshops will provide the following deliverables:
  - **2.3.1.** Curriculum: How many and what types of workshops will be offered? Would the workshops require different skill levels and/or be offered in a series (i.e. level one, level two, etc.)? or could they be taken independently of each other?
    - **Please note**: While trail builders, bicycle mechanics and snow sports technicians have been identified as areas most in need of these types of skill building workshops, bidders are welcome to propose additional skill areas within outdoor recreation as long as a compelling rationale is included.
  - **2.3.2. Framework:** How will instruction be delivered? What will the requirements be for successful completion (e.g. classes taken, hours of instruction, etc.)?
  - **2.3.3. Instructors:** How will instructors be trained or recruited? What qualifications will they be required to have or obtain?
  - **2.3.4.** Experiential Opportunities: How will the program provide hands-on training?
  - **2.3.5. Timeline:** When could instruction begin? When would marketing and/or recruitment efforts begin? How many workshops, and how many of each type of workshop, could be offered before the finding deadline (i.e. within 12 months)?
  - **2.3.6. Students:** How many students are anticipated to be enrolled? Is there a specific student-profile or target audience for these workshops? Please provide projected participation numbers.

- **2.3.7.** Marketing: How will potential participants be recruited to participate?
- **2.3.8.** Credential: What document or other credentials will result from successful participation in the program?

#### 3. GENERAL REQUIREMENTS:

- **3.1. Pricing.** Bidders must price the terms of this solicitation at their best pricing. Any and all costs that Bidder wishes the State to consider must be submitted for consideration. If applicable, all equipment pricing is to include F.O.B. delivery to the ordering facility. No request for extra delivery cost will be honored. All equipment shall be delivered assembled, serviced, and ready for immediate use, unless otherwise requested by the State.
  - **3.1.1.** Prices and/or rates shall remain firm for the initial term of the contract. The pricing policy submitted by Bidder must (i) be clearly structured, accountable, and auditable and (ii) cover the full spectrum of materials and/or services required.
  - **3.1.2.** Cooperative Agreements. Bidders that have been awarded similar contracts through a competitive bidding process with another state and/or cooperative are welcome to submit the pricing in response to this solicitation.
- 3.2. Statement of Rights. The State shall have the authority to evaluate Responses and select the Bidder(s) as may be determined to be in the best interest of the State and consistent with the goals and performance requirements outlined in this RFP. The State of Vermont reserves the right to obtain clarification or additional information necessary to properly evaluate a proposal. Failure of vendor to respond to a request for additional information or clarification could result in rejection of that vendor's proposal. To secure a project that is deemed to be in the best interest of the State, the State reserves the right to accept or reject any and all bids, in whole or in part, with or without cause, and to waive technicalities in submissions. The State also reserves the right to make purchases outside of the awarded contracts where it is deemed in the best interest of the State.
  - **3.2.1.** Best and Final Offer (BAFO). At any time after submission of Responses and prior to the final selection of Bidder(s) for Contract negotiation or execution, the State may invite Bidder(s) to provide a BAFO. The state reserves the right to request BAFOs from only those Bidders that meet the minimum qualification requirements and/or have not been eliminated from consideration during the evaluation process.
  - **3.2.2.** *Presentation.* An in-person or webinar presentation by the Bidder may be required by the State if it will help the State's evaluation process. The State will factor information presented during presentations into the evaluation. Bidders will be responsible for all costs associated with providing the presentation.
- **3.3.** Worker Classification Compliance Requirements. In accordance with Section 32 of The Vermont Recovery and Reinvestment Act of 2009 (Act No. 54), Bidders must comply with the following provisions and requirements.
  - **3.3.1.** Self-Reporting: For bid amounts exceeding \$250,000.00, Bidder shall complete the appropriate section in the attached Certificate of Compliance for purposes of self-reporting information relating to past violations, convictions, suspensions, and any other information related to past performance relative to coding and classification of workers. The State is requiring information on any violations that occurred in the previous 12 months.

- 3.3.2. Subcontractor Reporting: For bid amounts exceeding \$250,000.00, Bidders are hereby notified that upon award of contract, and prior to contract execution, the State shall be provided with a list of all proposed subcontractors and subcontractors' subcontractors, together with the identity of those subcontractors' workers compensation insurance providers, and additional required or requested information, as applicable, in accordance with Section 32 of The Vermont Recovery and Reinvestment Act of 2009 (Act No. 54). This requirement does not apply to subcontractors providing supplies only and no labor to the overall contract or project. This list MUST be updated and provided to the State as additional subcontractors are hired. A sample form is available online at http://bgs.vermont.gov/purchasing-contracting/forms. The subcontractor reporting form is not required to be submitted with the bid response.
- **3.4.** Executive Order 05-16: Climate Change Considerations in State Procurements. For bid amounts exceeding \$25,000.00 Bidders are requested to complete the Climate Change Considerations in State Procurements Certification, which is included in the Certificate of Compliance for this RFP.

After consideration of all relevant factors, a bidder that demonstrates business practices that promote clean energy and address climate change as identified in the Certification, shall be given favorable consideration in the competitive bidding process. Such favorable consideration shall be consistent with and not supersede any preference given to resident bidders of the State and/or products raised or manufactured in the State, as explained in the Method of Award section. But, such favorable consideration shall not be employed if prohibited by law or other relevant authority or agreement.

- **3.5.** *Regulation of Hydrofluorocarbons*. State procurement contracts shall not include products that contain hydrofluorocarbons, as prohibited in 10 V.S.A. § 586.
- **3.6. Method of Award.** Awards will be made in the best interest of the State. The State may award one or more contracts and reserves the right to make additional awards to other compliant bidders at any time if such award is deemed to be in the best interest of the State. All other considerations being equal, preference will be given first to resident bidders of the state and/or to products raised or manufactured in the state, and then to bidders who have practices that promote clean energy and address climate change, as identified in the applicable Certificate of Compliance.
  - **3.7.** Acceptance of contract terms and conditions included with this RFP will be evaluated on a pass/fail basis.
    - **3.7.1.** *Evaluation Criteria*. Consideration shall be given to the Bidder's project approach and methodology, qualifications and experience, ability to provide the services within the defined timeline, cost, and/or success in completing similar projects, as applicable, and to the extent specified below

- **3.8.** *Contract Negotiation.* Upon completion of the evaluation process, the State may select one or more Vendors with which to negotiate a contract, based on the evaluation findings and other criteria deemed relevant for ensuring that the decision made is in the best interest of the State. In the event State is not successful in negotiating a contract with a selected Vendor, the State reserves the option of negotiating with another Vendor, or to end the proposal process entirely.
- **3.9.** *Cost of Preparation.* Bidder shall be solely responsible for all expenses incurred in the preparation of a response to this RFP and shall be responsible for all expenses associated with any presentations or demonstrations associated with this request and/or any proposals made.
- **3.10.** *Contract Terms.* The selected bidder(s) will be expected to sign a contract with the State, including the Standard Contract Form and Attachment C as attached to this RFP for reference. If IT Attachment D is included in this RFP, terms may be modified based upon the solution proposed by the Bidder, subject to approval by the Agency of Digital Services.
  - 3.10.1. Business Registration. To be awarded a contract by the State of Vermont a vendor (except an individual doing business in his/her own name) must be registered with the Vermont Secretary of State's office <a href="http://www.sec.state.vt.us/tutor/dobiz/forms/fcregist.htm">http://www.sec.state.vt.us/tutor/dobiz/forms/fcregist.htm</a> and must obtain a Contractor's Business Account Number issued by the Vermont Department of Taxes <a href="http://tax.vermont.gov/">http://tax.vermont.gov/</a>.
  - **3.10.2.** The contract will obligate the bidder to provide the services and/or products identified in its bid, at the prices listed.
  - **3.10.3.** Payment Terms. All invoices are to be rendered by the Contractor on the vendor's standard billhead and forwarded directly to the institution or agency ordering materials or services and shall specify the address to which payments will be sent. Payment terms are Net 30 days from receipt of an error-free invoice with all applicable supporting documentation. Percentage discounts may be offered for prompt payments of invoices; however, such discounts must be in effect for a period of 30 days or more in order to be considered in making awards.
  - **3.10.4.** *Quality.* If applicable, all products provided under a contract with the State will be new and unused, unless otherwise stated. Factory seconds or remanufactured products will not be accepted unless specifically requested by the purchasing agency. All products provided by the contractor must meet all federal, state, and local standards for quality and safety requirements. Products not meeting these standards will be deemed unacceptable and returned to the contractor for credit at no charge to the State.
- 4. CONTENT AND FORMAT OF RESPONSES: The content and format requirements listed below are the minimum requirements for State evaluation. These requirements are not intended to limit the content of a Bidder's proposal. Bidders may include additional information or offer alternative solutions for the State's consideration. However, the State discourages overly lengthy and costly proposals, and Bidders are advised to include only such information in their response as may be relevant to the requirements of this solicitation.
  - **4.1.** Unsolicited Bidder-Confidential Information Prohibited. Bidders are hereby expressly directed not to include any confidential information in their proposal submissions, except as specifically permitted below, and so marked. By submitting a proposal in response to this RFP, bidders acknowledge and agree to abide by the terms and conditions outlined in this document, including the prohibition on submitting confidential information. This prohibition reduces the

burden on the State while preventing bidder-confidential information from entering the public record.

- 4.1.1. Disclosure under Public Records Act. All information received by the State in response to this RFP will become part of the contract file and subject to Vermont public records law. Responses by any bidder may become available to the public once a contract has been executed or otherwise following conclusion of this procurement process, in accordance with the State's Public Records Act, 1 V.S.A. § 315 et seq., or the State may choose to publicly post them.
- 4.1.2. Unsolicited Confidential Materials. This RFP does not solicit bidder confidential information and bidders are expressly prohibited from providing confidential information in response to this RFP. All materials furnished by bidders in response to this RFP, including those marked as confidential by bidders, are subject to disclosure if requested under the Public Records Act, or public posting.
- 4.1.3. State Not Responsible for Disclosure of Unmarked Bidder-Confidential Information. It is the sole responsibility of the bidder to ensure that, other than where specifically directed or permitted by this RFP and accordingly marked as described below, no information that should not be publicly disclosed is included in their proposal materials, including any 1) trade secrets or intellectual property, 2) proprietary financial or business information, 3) personal information, or 4) any other information that should not be disclosed to the public. For example, bidders should avoid including specific details of their proprietary technologies or methodologies that they consider confidential, and any references to previous client engagements should be presented in a manner that does not disclose the client's confidential information.
- **4.2. Cover Letter.** Provide a cover letter, on company letterhead, to introduce the bidder, and provide a brief description of the business, its service offerings, specialties and longevity in the industry. In addition, the cover letter should briefly highlight key attributes ideally suited for the services sought in the RFP that will be explored further in the technical response
  - **4.2.1.** *Exceptions to Contract Terms and Conditions*. The State will not consider exceptions to contract terms and conditions included with this RFP.
- **4.3.** *Technical Response.* In response to this RFP, Bidder shall address the following:
  - **5.3.1.** *Description of Approach*: How will the workshops proposed deliver the elements described in Section 2.3. above.
  - **5.3.2. Statement of Qualifications**: What makes your organization uniquely qualified to do this work in Vermont?
  - **4.3.1.** Provide details concerning your form of business organization, company size and resources.
  - **4.3.2.** Describe your capabilities and particular experience relevant to the RFP requirements and identify all current or past State projects.
  - **4.3.3.** Identify the names of all subcontractors you intend to use, the portions of the work the subcontractors will perform, and address the background and experience of the subcontractor(s), as per RFP section 3.3.2 above.

- **4.4.** *References.* Provide the names, addresses, and phone numbers of at least three companies with whom you have transacted similar business in the last 12 months. You must include contact names who can talk knowledgeably about performance.
- **4.5.** *Reporting Requirements.* Provide a sample of any reporting documentation that may be applicable to the Detailed Requirements of this RFP.
- **4.6.** *Certificate of Compliance.* This form must be completed and submitted as part of the response for the proposal to be considered valid.
- **4.7.** *Price Proposal.* Bidders shall submit their pricing information in the Price Schedule attached to the RFP.

#### 5. SUBMISSION INSTRUCTIONS:

- **5.1.** Closing Date. Bids must be received by the State by the due date specified on the front page of this RFP. Late bids will not be considered.
  - **5.1.1.** The State may, for cause, issue an addendum to change the date and/or time when bids are due. If a change is made, the State will inform all bidders by posting at the webpage indicated on the front page of this RFP.
  - 5.1.2. There will not be a public bid opening. However, the State will record the name, city and state for any and all bids received by the due date. This information is available upon request to the single point of contact identified on the cover of this RFP...
- **5.2.** *Bid Delivery Instructions.* All bid proposals must be submitted in digital format as described below. No hard copies, faxes or in-person delivery will be accepted.





Negotiation to settle a timely claim shall be for the sole purpose of reaching a settlement equitable to both the Contractor and the State. To the extent settlement is properly based on Contractor costs, settlement shall be based on actual costs incurred by the Contractor, as reflected by the contract rates. Consequential damages, loss of overhead, loss of overhead contribution of any kind, and/or loss of anticipated profits on work not performed shall not be included in the Contractor's claim and will not be considered, allowed, or included as part of any settlement.
