## **FY24 Bylaw Modernization Grant Projects**

Bylaw Modernization Grants will support local zoning bylaw updates to enhance the production of affordable homes in development-ready places, confront the State's housing crisis, and help communities become more equitable, energy-smart, and economically strong and affordable. This third round of Bylaw Modernization Grants is awarded by the Department of Housing and Community Development with funding appropriated by the legislature. Municipalities will use \$105,808 in fiscal year 2024 State funding to hire regional planning commission or consulting staff with expertise in bylaw writing and public outreach. This year's grant leveraged \$14,957 in local match funding and will support 7 projects in 6 regional planning commission regions. The Department received a total of 12 applications requesting over \$212,558 in funding. Descriptions of the FY24 projects are listed below. These awards build upon last year's grants, bringing the total number of municipalities served to 63, 27% of municipalities with adopted zoning in Vermont.

**Braintree** will improve its zoning bylaw to help address the urgent statewide housing shortage. This project will engage the community in discussions of the zoning process, and will work to educate the public on the benefits that new and diverse housing models can bring to Braintree. **Jericho** will hire a consultant to work with the Planning Commission to develop zoning amendments, simplify and update existing regulations, and make other changes recommended in the Enabling Better Places guide to increase affordable housing and mixed-use buildings and streamline permitting processes. **Manchester Village** will be developing Land Use & Development Regulations that combine existing zoning bylaws with targeted revisions. This will create a streamlined land use and development ordinance, drawing together all the separate regulatory instruments into one, including subdivision standards.
