Josh Hanford brought the meeting to order at 1:02 pm via GoTo Meeting virtual conference call.

Board members inquired if future Downtown Designation 4-Year Review conversations can include information pertaining to any development within the downtown in the four-year period that is under review. Gary Holloway advised he would include development questions going forward.

3. Growth Center Designation Request – Jacob Hemmerick

The Town of Hartford was originally scheduled for review in March of 2020. At the January meeting, the Downtown Board extended the deadline to September 2020 at the request of the Town to address a convergence of critical work items and the prospect of a sewer line extension to Norwich, which could affect Growth Center findings and boundaries. Due to the challenges of COVID, the Town of Hartford requests an additional 90-day extension for submittals, from the date the emergency order expires. Approval of this request -- under the current order -- would postpone review until April 2021, with submissions in January 2021.

Trish Sears made a motion to postpone the Growth Center 5-year review submission deadline to January (for April 2021 review) or no more than 90 days from the expiration of a future emergency declaration extension, Chip Sawyer seconded. Ayes; Billy Coster, Bruce Cheeseman, Chip Sawyer, Ed Bove, Greg Boulbol, Laura Trieschmann, Michael Desrochers, Michael McDonough, Michele Boomhower, Trish Sears, and Josh Hanford. The motion carried.

4. Old Business / New Business

Chris Cochran and Josh Hanford provided board members with an overview of legislation that passed during the shortened summer session:

- Tax Credits The budget bill included a \$400,000 increase to the downtown and village center tax credit cap taking it to \$3M annually. Efforts to expand the program eligibility to the neighborhood development areas failed. The increase will enable a winter round of tax credits.
- S237 The legislature passed modest but important changes to streamline local permitting for housing. Specifically, the bill exempts character based appeals for small housing projects, enables the use of existing smaller lots that can connect to water and sewer infrastructure, makes it easier to build an accessory dwelling unit on a single-family home lot, allows municipalities to regulate short-term rentals, limits new covenants and deed restrictions that local regulations allow, and directs DEC to assist in the implementation of Brattleboro's Tri-Park master plan. The bill awaits the Governor's signature.
- Act 250 The legislature sent the Governor a slimmed down bill with modest changes for forests integrity and trail permitting for his signature. We expect the legislature will take the exemptions for designated centers and reintroduce other unfished businesses from this biennium in January.

Board members asked if at an upcoming meeting if the applications for the New Town Center, Growth Center, and Neighborhood Development Areas could be reviewed and updated as needed. DHCD staff will schedule these reviews for an upcoming meeting.
