

Program Overview

Annual Summary of Activities for Program Year 2021 (7/1/2020-6/30/2021)

The Vermont Community Development Program (VCDP) administers funding from the U. S. Department of Housing and Urban Development (HUD) under the Community Development Block Grant (CDBG) program. Activities that support economic development and affordable housing continue to be VCDP's top priorities for funding. The VCDP assists communities on a competitive basis by providing financial and technical assistance to identify and address local needs in the areas of housing, economic development, public facilities, public services and handicapped accessibility modifications. The program is designed to predominantly benefit persons of low and moderate income. In addition, financial assistance is provided to communities with urgent needs, such as threats to health and safety and removal of slums and blighted properties. 2021 CDBG Program Accomplishments

The CDBG allocation for the last program year was \$7,246,223. Program income from previous grants, other returned funds from prior grants, and a forward commitment of next year's allocation made it possible to fund all the projects below. As a result this past year VCDP was able to award over \$10 million to 37 projects, which leveraged over \$84 million dollars. The funds were awarded to housing, economic development, public facility, public service and planning projects. A breakdown of awards made this year, by project types, follows on pages 2 and 3. Thirteen previously funded projects were enhanced to continue their services or to ensure project completion due to increased project costs.

2021 CDBG-CV Program Accomplishments

Due to the COVID19 coronavirus pandemic the CDBG program received three allocation totalling \$8.8 million of CDBG-CV Cares Act funding. This past year VCDP awarded nearly \$7 million of the CDBG-CV funds to 23 projects. The funds were awarded to housing, economic development, public facility, and public service projects to prevent, prepare for and respond to the spread of the coronavirus. CDBG Housing Grants

The VCDP awarded nine and enhanced six grants to housing projects that totalling \$6,753,885 in CDBG funding and leveraged over \$66 million in local, private and other federal and state resources. This collaborative effort will create or preserve 317 units of affordable housing and makes a significant contribution in addressing the affordable housing crisis. An additional \$208,188 will be used by the three revolving loan fund programs below to provide first time homeowner educational training and financial counseling to income eligible homeowners in need of home repair. The programs anticipate serving 598 households.

CDBG Public Facility and Service Grants

The VCDP awarded five and enhanced two public facility grants that nearly totalled \$2.5 and leveraged over \$14 million in other resources. The VCDP awarded one and enhanced four public service grants that totalled \$508,188 and leveraged nearly \$2 million in other resources. The following community facilities and service projects will help assist a childcare center, two community centers, a community septic for a mobile home park, a municipal parking garage, a recovery residence, a municipal library with handicapped access, and at risk youth program.

CDBG-CV Economic Development Grants

Vermont businesses closed and struggled due to the onset of the COVID19 pandemic in 2020. \$250 million of Vermont's Economic Recovery Package went to respond to needs of Vermont businesses. The CDBG program worked closely with the programs disbursing funds to businesses, and through that collaboration found a gap in funding available for sole proprietor businesses. VCDP provided over \$3.5 million of the CDBG-CV funding to assist sole proprietor businesses throughout the state.

CDBG-CV Public Facility and Service Grants

The VCDP awarded 21 public facility and service grants CDBG-CV funding that nearly totalled \$3.3 to prevent, prepare for and respond to the COVID19 pandemic. The following community facilities and service projects will help provide air quality improvement and HVAC systems to several facilities, sanitation and cleaning supplies and operational costs for a child care facilities, food storage for increased food insecurities for families, expand the pool of health care workers and technicians to respond to the spread of infectious disease, expand services for a warming shelter for the homeless, provide financial counseling and emergency payments for housing related costs in the form of mortgage, rental, and utility payment assistance.

2021 Recovery Housing Program (RHP) Accomplishments

Due to the State of Vermont's opioid death rate the VCDP program received an allocation totalling \$753,000 from HUD's Support Act funding, Recovery Housing Program a pilot program to help individuals in recovery from substance use disorders (SUD) become safely housed. This funding is to support the creation of transitional housing for Vermonters suffering from SUD and safely house them for up to 2 years. VCDP staff worked with various stakeholders and the Agency of Human Services to get this pilot Recovery Housing Program up and running during this time period.

This past year RHP awarded a total of \$700,000 to 2 projects. A breakdown of awards made this year, by project types follows below.

RHP Recovery Housing Grants

The Recovery Housing Program supported two projects: one project in the City of Barre that will provide transitional housing to women and their children that are homeless and suffering from SUD, and another project in the Town of Johnson that will provide 8 beds to women suffering from SUD that will provide transitional housing for up to 2 years. The Town of Johnson's project was also funded by CDBG funds that supported funding a cafe downstairs that will provide employment to individuals that are recovering from SUD. Both projects will have wrap around services to support the recovery needs of their residents.
