Program Overview

Annual Summary of Activities for Program Year 2022 (7/1/2021-6/30/2022)

The Vermont Community Development Program (VCDP) administers funding from the U. S. Department of Housing and Urban Development (HUD) under the Community Development Block Grant (CDBG) program. Activities that support economic development and affordable housing continue to be VCDP's top priorities for funding. The VCDP assists communities on a competitive basis by providing financial and technical assistance to identify and address local needs in the areas of housing, economic development, public facilities, public services and handicapped accessibility modifications. The program is designed to predominantly benefit persons of low and moderate income. In addition, financial assistance is provided to communities with urgent needs, such as threats to health and safety and removal of slums and blighted properties. 2022 CDBG Program Accomplishments

The CDBG allocation for the last program year was \$7,436,844. Program income from previous grants, other returned funds from prior grants, and a forward commitment of next year's allocation made it possible to fund all the projects below. As a result this past year VCDP was able to award over \$6 million to 23 projects, which leveraged over \$47 million dollars. The funds were awarded to housing, public facility, public service and planning projects. A breakdown of awards made this year, by project types, follows on pages 2 and 3. Nine previously funded projects were enhanced to continue their services or to ensure project completion due to increased project costs.

2022 CDBG-CV Program Accomplishments

Due to the COVID19 coronavirus pandemic the CDBG program recieved three allocation totalling \$8.8 million of CDBG-CV Cares Act funding. This past year VCDP awarded nearly \$7 million of the CDBG-CV funds to 23 projects. The funds were awarded to housing, economic development, public facility, and public service projects to prevent, prepare for and respond to the spread of the coronavirus. CDBG Economic Development Grants

Over the past couple of years the VCDP has seen a decline in economic development grant requests, this year none were received. We suspect the reasoning for the lack of request is due to the unprecedented other funding sources that became available for economic development projects due to the COVID19 pandemic, including CDBG-CV Cares Act funding which is outlined below.

CDBG Housing Grants

The VCDP awarded four and enhanced six grants to housing projects that totalling \$4,326,979 in CDBG funding and leveraged over \$39 million in local, private and other federal and state resources. This collaborative effort will create or preserve 234 units of affordable housing and makes a significant contribution in addressing the affordable housing crisis. An additional \$206,521 will be used by the three revolving loan fund programs below to provide first time homeowner educational training and financial counseling to income eligble homeowners in need of home repair. The programs anticipate serving 968 households.

Vermont communities are afforded opportunities to undertake community development planning through technical expertise and professional resources for one or more of the VCDP areas of eligibility – housing, economic development, public facilities and public services. The VCDP awarded six and enhanced two grants for planning projects totalling \$303,445 that were provided to communities throughout Vermont.

CDBG Public Facility and Service Grants

The VCDP awarded four and enhanced one public facility grants that totalled \$1,350,000 and leveraged over \$5 million in other resources. The VCDP did not receive any public service grant request this past year. The following community facilities projects will help assist a recovery support services center, a community wellness center, a recovery residence, and bringing a former school building into compliance with life and safety codes for redevelopment.

2021 Recovery Housing Program (RHP) Accomplishments

Due to the State of Vermont's opiod death rate the VCDP program recieved allocations for FY20, FY21 & FY22 totalling \$2,299,711 from HUD's Support Act funding, Recovery Housing Program a pilot program to help individuals in recovery from substance used disorders (SUD) become safely housed. This funding is to support the creation of transitional housing for Vermonters suffering from SUD and safely house them for up to 2 years. VCDP staff continue to work with various stakeholders and the Agency of Human Services on this pilot Recovery Housing Program to assure these funds are creating safe housing for Vermonter's in recovery.
