




# Department of Economic Development Community Recovery and Revitalization Program Report

The Community Recovery and Revitalization Program (CRRP) provides funding for projects that spur economic recovery in communities across the state. Eligible uses for these funds include capital improvements related to the creation of childcare and affordable housing for low- and moderate-income households, capital projects that assist small businesses operating in identified industries most impacted by the pandemic or pursuing projects in low-income census tracts, and municipal water supply and wastewater projects that build housing or create jobs. \$40,000,000 from American Rescue Plan Act (ARPA) – Coronavirus State Fiscal Recovery Funds was appropriated to fund awards by the CRRP. Pursuant to Act 183, the Legislature directed the program to submit this report regarding the following: (1) a description of the implementation of the program; (2) the promotion and marketing of the program; and (3) an analysis of program utilization and performance.

## Executive Summary

Vermont was awarded \$1.05 billion in Coronavirus State and Local Fiscal Recovery Funds as part of the Federal American Rescue Plan Act of 2021. A portion of these funds were distributed under Act 183, and 185, signed by Governor Scott on June 8, 2022. Sec. 53 (c)(1) of Act 183 appropriated \$10,000,000, and Section G 300(a)(5) of Act 185 appropriated \$30,000,000 to create the Community Recovery and Revitalization Program (CRRP) to make funding available to address the negative economic impacts of COVID-19 on Vermont's economy, employers, workers, and families while simultaneously leveraging opportunities to grow Vermont's economy. These recovery funds are intended to retain and expand existing businesses and nonprofit organizations with a preference for projects that primarily serve BIPOC populations and projects located in regions and communities with declining or stagnant grand list values.

This grant program started accepting applications on November 29, 2022. For the first 30 days, as part of the State of Vermont's commitment to build on local, state, and national efforts to advance equity and to increase meaningful inclusion and representation of BIPOC (Black, Indigenous, and People of Color) communities, ACCD prioritized applications from BIPOC organizations and organizations that primarily serve BIPOC populations. ACCD also prioritized the review of applications from non-Metropolitan Statistical Areas (non-MSAs) in the first 30 days. A Metropolitan Statistical Area (MSA) is a designation used by the Federal government to identify multi-county clusters with a population density of at least 50,000. In Vermont, non-MSA communities are in Addison, Bennington, Caledonia, Essex, Lamoille, Orange, Orleans, Rutland, Washington, Windham, and Windsor counties. The application portal will stay open until all funds are allocated.

As of February 1, 2023, DED has received 83 complete applications for the CRRP program totaling \$36,873,332 in capital investment requests. DED has received 7 BIPOC (either owned, managed, or serving) applicants and 40 applications from non-MSA counties.



## Program Overview

The Community Recovery and Revitalization Program was created based upon the language set forth in Act 183. Eligible applicants include both for- and non-profit businesses: in identified impacted industries; located within Qualified Census Tracts; pursuing affordable housing; creating or expanding childcare facilities for low to moderate income families; as well as municipalities pursuing water and wastewater projects where the project supports development of affordable housing or business expansion.

## Impacted Industries

To target those industries that were disproportionately impacted by the negative economic impacts of the COVID-19 pandemic, CRRP targets the following Impacted Industries with North American Industry Classification System (NAICS) codes that start with the following two digits:

- 11 (Agriculture)
- 61 (Educational Services)
- 71 (Arts, Entertainment, & Recreation)
- 72 (Accommodation & Food Services)

## Award Calculations and Considerations

Awards will not exceed the lesser of \$1,000,000 or 20% of total project cost and will be calculated based on the merit of the application. The merit of the application will be determined based on the following considerations:

- Project readiness, including the status of any necessary permits
- The demonstrated availability of the balance of the other sources of funding (including availability and eligibility of other sources of funding)
- Community impact (e.g., number of childcare slots, housing units, business development, etc.)
- Prior experience with grants and/or adequate staff to comply with the terms of the grant agreement
- Regulatory issues that may complicate the completion of the project
- The ability of the applicant to receive project funding through more traditional funding streams



- Demonstrated applicant need, including the project's remaining gap in funding and how the project would differ if not for the CRRP funds.
- Evidence of good standing with the Vermont Secretary of State
- Community and regional support for the project
- Creation of Vermont-based jobs
- Applicants that have received a Capital Investment Program (CIP) award must also factor CIP into their total CRRP award calculation. The combined CIP and CRRP award cannot exceed the lesser of 20% of total project cost or \$1,000,000 (i.e. the award limit takes into account both CIP and CRRP programs)
- Applicants are asked to disclose prior accepted Federal or State recovery assistance (i.e. Paycheck Protection Program loans or State Emergency Recovery Grants such as Economic Recovery Bridge Program grants, Ski Area Recreation Safety grants, Vermont Housing Improvement Program grants, and Capital Investment Program grants) in an effort to avoid duplication of benefits uses.

## Coordination with Joint Fiscal Office

Pursuant to Act 183, DED collaborated with JFO to develop guidelines and approval processes for the Program. These guidelines and approval processes were submitted to the JFC and the chairs of the relevant legislative committees of jurisdiction prior to accepting applications for grants through the Program.



## Application and Review Procedures

Between November 9 and November 14, 2022, DED hosted five live webinars to promote the different tracks of funding available for the CRRP program. DED's website posted the recorded webinars for those that were unable to attend. DED collaborated with community partners to reach as many members as possible of the public, including those in BIPOC and underserved communities throughout Vermont. DED published a special newsletter announcement raising additional awareness for the program. The CRRP website detailed information on the program eligibility requirements, eligible use tracks, and FAQ's. The technical assistance team at DED answered questions via a designated email. Translation services were available for those who requested. On November 29, 2022, DED opened the application portal to the public.

A 30-day priority period was established for organizations that are led by BIPOC individuals or serve BIPOC populations and non-MSA applications. During the 30-day priority period, only applications meeting at least one of these criteria were considered. These applications continue to receive priority review.

Award decisions will be made quarterly or with more frequency depending on the volume. The first round of funding decisions will be announced in the next 30 days.

## Review Procedures: Collaboration with Other Agencies and Boards

After an initial eligibility determination, applications for projects that support the creation of affordable housing or childcare slots are sent to the Department of Housing and Community Development (DHCD) or the Department of Children and Families (DCF) respectively. Partners at DHCD and DCF review each application and provide input about the applicant, the specific project (if known), and how likely the applicant is to receive adequate funding for the project through other traditional funding channels.

For municipal applications, Vermont Economic Progress Council (VEPC) staff complete an initial eligibility review and sends the application to the Agency of Natural Resources (ANR) for review and input. VEPC staff then present successful applicants to the VEPC Board at monthly meetings for review and consideration of the nexus of the project to either affordable housing or business development and of the "but for" requirement. Applications approved by the VEPC Board are then sent to DED leadership with a recommendation for approval or denial.

Once approved by DED leadership, projects are forwarded to the Interagency Review Team, made up of cabinet officials from Agency of Administration, Agency of Human Services, Agency of Natural Resources, Agency of Transportation, Department of



Public Safety, Public Service Department, and Agency of Agriculture Food and Markets, to see if there are any conflicts or issues with the intended awardees. Once approved by the Interagency Review Team, a final determination is made by DED leadership, and applicants are simultaneously notified of their successful application.

## Program Status:

### **CRRP Quarter 1: 11/30/22 – 2/1/23**

As of February 1, 2023, the Department of Economic Development received 83 complete applications. In addition, 14 applications were received in this period and returned to the applicant for correction or additional information.

The 83 complete applications request \$36,873,332 in funding to assist with project costs totaling \$408,840,497. Of these 83 projects, 31 have been proposed to the Interagency Review Team for round 1 funding, resulting in a proposed award amount of \$9,828,085 which is expected to support \$153,515,054 in total project costs. Upon receiving final approval, these 31 projects proposed for awards will undergo a process to finalize details with CRRP staff prior to awards being obligated.



#### Priorities:

- The 31 projects proposed for CRRP awards will support 354 existing jobs and enable the creation of 205 new jobs.
  - During the first quarter of the program, 7 applicants indicated their organization was BIPOC led, or their project was BIPOC serving. Of these, four applicants are proposed to receive a round 1 award.
  - Of the 83 complete applications, 40 of the projects are in towns with stagnant or declining grand lists. Of those, 16 are proposed for a round 1 award.

## Applications and Awards by Project County

The CRRP program has received applications from all 14 Vermont counties. Round 1 includes prospective awards to applicants in 12 Vermont counties. During round 1, DED prioritized making awards to applicants from non-MSA counties, which excludes Chittenden, Franklin, and Grand Isle counties. The 3 proposed awards in these MSA counties are for projects that demonstrate a high level of priority, including: a large childcare project, a BIPOC serving project in a QCT, and a municipal water/wastewater project on the regional priority list.







## Applications and Awards by Applicant Type

The CRRP program has received complete applications from 30 for profit businesses, 48 nonprofit businesses, and 5 municipalities. Round one includes awards to 11 for-profit businesses, 18 non-profit businesses, and 3 municipalities.

Proposed Round 1 Awards: Applicant Type







## Applications and Awards by Application Track

There are 5 “tracks” to qualify for the CRRP program: housing, childcare, impacted industry, qualified census tract (QCT), and municipal water/wastewater projects. CRRP received applications from 19 housing projects, 7 childcare projects, 47 impacted industry projects, 8 projects located within a QCT, and 5 municipal water/wastewater projects. Round one awards include 5 housing projects estimated to create 79 new affordable units, 4 childcare projects creating 196 new childcare slots for low to moderate income families, 16 impacted industry projects with projects in each eligible industry, 6 projects located within qualified census tracts, and 3 municipal water/wastewater projects.

Note: Some applicants are listed under more than one category (ex: an impacted industry within a QCT)







## Applications and Awards by Impacted Industry

The Impacted Industry eligibility track targets 4 “Impacted Industries” (which are industries deemed by The U.S. Department of the Treasury to be disproportionately impacted by the COVID 19 Pandemic). CRRP targets four Impacted Industries with North American Industry Classification System (NAICS) codes that start with the following two digits: 11 (Agriculture), 61 (Educational Services), 71 (Arts, Entertainment, & Recreation), 72 (Accommodation & Food Services). Applicants who can also demonstrate that they are dependent on one of these impacted industries may qualify under that industry.

Of the 47 applicants who applied as an impacted industry, 6 are in agriculture; 7 are in educational services; 22 are in arts, entertainment, & recreation; and 12 are in accommodation & food services. Round 1 proposed awards include: 3 projects in agriculture; 3 in educational service; 7 in arts, entertainment, & recreation; and 2 in accommodation and food services.

As part of the State of Vermont's commitment to build on local, state, and national efforts to advance equity, and increase meaningful inclusion representation of BIPOC communities, the Department of Economic Development (DED) will prioritize applications that demonstrate meaningful impact on Vermont's BIPOC population. For the first 30 days of this program, DED will prioritize the review of applications that serve BIPOC (Black, Indigenous, and People of Color) communities and from municipalities and organizations located in Addison, Bennington, Caledonia, Essex, Lamoille, Orange, Orleans, Rutland, Washington, Windham, and Windsor counties. After 30 days, all applications will be reviewed.
