(2) If at the 3 digit level, the historical growth rate is NOT greater than 1.5 times the historical growth rate for all private industries (4.6%), then the background growth rate will be the historical growth rate for that industry on the 3 digit level.

(3) If at the 3 digit level, the historical growth rate is greater than 1.5 times the historical growth rate for all private industries (4.6%), then the background growth rate will be the GREATER of the appropriate 2 digit NAICS code for the applicant's industry OR the historical growth rate itself (4.6%)

(4) If the historical data for the appropriate 3 digit NAICS code is not available, then the appropriate 2 digit NAICS code will be selected.
