Good morning Elizabeth,

I took this matter to our Historic Preservation Review Committee; the representative body of our CLG in Burlington. I have attached the minutes from that meeting.

In short, the HPRC **does not support de-listing** the property; citing its commonality with other dwelling types in the immediate area of St. Paul Street that date from the mid 19th century. I have also attached a Title review, clearly defining its date between 1853 and 1857. It appears on both the 1869 Beers Atlas Map and the 1877 Birds-Eye (Hopkins) map of Burlington; one of a pair of similarly sized dwellings. The north example is no longer extant.

The HPRC recognizes the unsympathetic alterations with vinyl siding over masonry and porch/window alterations; however supports its retention on the Vermont State Register due to the contextual relationship with similar dwellings in the area and retention of building massing, form, and association. They are particularly interested in understanding any planned redevelopment which would be reviewed under our specific standards for the treatment of historic structures (Section 5.4.8); and only if the building retains its historic designation.

I will likely attend the ACHP meeting in January.

II. Request before the Vermont Advisory Council to de-list 263 St. Paul Street from the Vermont State Register of Historic Resources.

Motion by Jay White: Within our discussion, we find that 263 St. Paul Street is a residential type consistent with other similar buildings on St. Paul Street, and presents a pattern common to the mid-19th century in form, design, association, and (likely) materials. (Masonry under vinyl; stone foundation evident on northeast corner.) We find the staff comments made on the DOE form incorrect; dwelling dates to 1853-57 (see Title) and at least one turned porch post remains. Although we recognize unsympathetic alterations. We see no reason to de-list this structure, and would prefer to retain its listing where it would be reviewed under Section 5.4.8.of the Comprehensive Development Ordinance where redevelopment is proposed.

It is also noted that this was the home of Esther Sorrell, long-time Burlington Democratic Party leader who served five terms in the Vermont State Senate and for a period of time was the only female senator. 263 St. Paul Street had been the childhood home of her husband, Thomas W. Sorrell (whose mother was Irene Proulx Sorrell McGreevey).


