Justification for Eligibility Recommendation: The Hitchcock Memorial Museum and Library is eligible for the State Register of Historic Places under Criterion A: Event for its significance as an important local educational institution. It represents a rare combination of public library and natural history museum, perhaps inspired by the Fairbanks Museum in St. Johnsbury built in 1890. It is also eligible under Criterion C: Design/Construction for its Colonial Revival architecture and elaborate interior design and finishes. Its architectural significance is primarily focused on the interior of the building, which features elaborate woodwork and shelving for the first-floor library. The center of the second floor is open to the floor below and encircled by a balcony with museum exhibits and display cases.
