

I. Introduction:

While a substantial portion of the VTrans Environmental Section's workload under Section 106 is conducted under the VTrans Programmatic Agreement Among the Federal Highway Administration, the Vermont Agency of Transportation, the Advisory Council on Historic Preservation, and the Vermont State Historic Preservation Officer Regarding Implementation of the Federal-Aid Highway Program in Vermont (PA), VTrans cultural resources staff are also reviewing Federal Rail Administration (FRA), Federal Aviation Administration (FAA), Federal Transit Administration (FTA), and Federal Emergency Management Agency (FEMA) projects. Those projects are not addressed or accounted for in this report. This report addresses FHWA Federal Aid Projects reviewed by VTrans under the PA and one project that resulted in a determination of Adverse Effect.

This programmatic agreement is essential in assisting VTrans' 36 CFR qualified staff keep up with the constant flow of work requests, while maintaining our steadfast commitment to the mitigation hierarchy and our agency-wide ethos of environmental excellence and top-notch customer service. Without this tool, both VTrans and VDHP staff would be unable to keep VTrans projects on schedule and budget.

Staff changes have been a theme this past year. VTrans has a new Chief Engineer, Jeremy Reed, and the Environmental Section Manager, Nick Wark, is moving to exclusively manage the Right of Way Section. Al Honsinger has moved on to work in the private sector, and thankfully is still supporting VTrans projects as a consultant. In March, the Environmental Section welcomed Cultural Resources Specialist, Emily Baker. Along with tremendous enthusiasm, Emily brings to VTrans a BA in Anthropology from UNH and a MS in Historic Preservation from UVM. She has quickly become an essential part of the team supporting both archaeology and historic preservation disciplines. And after 14 years of dedicated service as a VTrans archaeologist, Brennan Gauthier is moving on to greener pastures. Happy Trails, Brennan!

Other changes include a partial return to the office. VTrans staff is returning to the office for, at least, one day per week - which will foster greater collaboration and team building.

In addition to project review, VTrans Cultural Resources Team is actively involved with streamlining and stewardship initiatives supported by FHWA. These include:

- Participating in rewriting the guidelines for conducting historic archaeology in Vermont
- Mobile Properties MPDF
- Historic Bridge Program status review of historic bridges of the state

We are extremely grateful to our peers at VDHP for their quick and collaborative response to emergency, emergent, and priority projects – which land on top of our normal programmed projects. The flood of 2024 has added a significant amount of ER projects to the cultural resource team's already full plate. Moreover, both VTrans and VDHP staff have spent copious hours on the Burlington-Winooski Bridge project – which has resulted in an excellent and massive S106 document. It has been a very busy year. VTrans Qualified Staff continues to enjoy the ongoing project dialogs with their colleagues at VDHP, whether that is spontaneous project

phone calls or the open invitation to VDHP's Environmental Review meetings. We look forward to continued collaboration during the next reporting period.

II. Table of Summary Statistics

VTrans reviewed a total of 56 projects for potential impacts to historic and cultural resources as part of the project review process under the *Programmatic Agreement Among the Federal Highway Administration, the Vermont Agency of Transportation, the Advisory Council on Historic Preservation, and the Vermont State Historic Preservation Officer Regarding Implementation of the Federal-Aid Highway Program in Vermont (PA).* One additional project, Fairfield BO 1448(46), was also reviewed this year but as it resulted in an Adverse Effect determination, the project was not reviewed under the terms of the PA.

VTrans is streamlining roadway corridor projects involving culvert replacements. In the past, the Cultural Resources Team reviewed culvert replacement projects that typically included one or possibly several culverts. VTrans project designers are now submitting culvert replacement projects for long corridor improvement projects and these new submittals include all the culverts to be repaired or replaced along that entire length of roadway. So, instead of reviewing multiple submittals that look at only one or a few culverts along a length of road, we are instead reviewing fewer submittals that each contain multiple culverts. This means that the counts above, mostly for Exempt, Screened, and NHPA projects, may appear reduced from previous years. Despite this change, we will continue to have isolated culvert repair and replacement projects that are not part of any overall corridor improvement initiative.

III. Assessment of Effectiveness of PA, Concerns, and Recommendations for Changes

This Programmatic Agreement enables VTrans and SHPO to process a large amount of FHWA funded undertakings as efficiently as possible while ensuring S106 is adequately addressed. This agreement serves as a first-rate example of effective efficient and collaborative interagency partnership within VT state government.

At this point VTrans does not have any recommendations for changes to this agreement and continues to enjoy the benefits of an agreement that can serve as a model for interagency cooperation. We look forward to working with our colleagues at VDHP and FHWA in 2025.
