V. State Register of Historic Places

a. Old North Church, Danville

Devin Colman presented Old North Church in Danville for consideration for listing in the State Register of Historic Places. Sally Fishburn and the Danville Historical Society prepared the nomination. The resource was considered under Criterion A for Social History and Criterion C for Architecture, with a period of significance from 1832 to 1960.

Ann Vivian made a motion that Old North Church meets the State Register Criteria for Evaluation and list it in the State Register of Historic Places; Joe Luneau seconded the motion.

b. Hitchcock Memorial Museum and Library, Westfield

Devin Colman presented the Hitchcock Memorial Museum and Library in Westford for consideration for listing in the State Register of Historic Places. Jennifer Stelma and the Hitchcock Memorial Museum and Library prepared the nomination. The resource was considered under Criterion A for Education and Criterion C for Architecture, with a period of significance of 1899. David Skinas inquired if any Native American items are on display and recommended coordination to the State Archaeologist.

Paul Carnahan made a motion that Hitchcock Memorial Museum and Library meets the State Register Criteria for Evaluation and list it in the State Register of Historic Places; Britta Tonn seconded the motion.

c. Farmstead, 1492 Kenyon Road, Richmond

Devin Colman presented the farmstead at 1492 Kenyon Road in Richmond for consideration for listing in the State Register of Historic Places. He prepared the nomination. The resource was considered under Criterion A for Agriculture and Criterion C for Architecture, with a period of significance from c. 1850 to c. 1950. David Skinas requested a Vermont Archaeological Inventory form for the former house and sawmill sites be created. Property owners Stephanie Kamin and Dean Slocum have additional information to date the sugarhouse.

Britta Tonn made a motion that farmstead at 1492 Kenyon Road meets the State Register Criteria for Evaluation and list it in the State Register of Historic Places; Paul Carnahan seconded the motion.

VI. National Register of Historic Places

a. H.H. Mower General Store, Sheldon

Devin Colman presented the H.H. Mower General Store in Sheldon for consideration for listing in the National Register of Historic Places. This is a Preservation Trust of Vermont Paul Bruhn Grant related project. Polly Allen served as the qualified professional.

Period of Significance is 1932 to 1950, recommending listing under Criteria A and C, with Commerce, Social History, and Architecture as the Areas of Significance.

Mr. Wyncoop made a motion that the H.H. Mower General Store in Sheldon meets the National Register Criteria for Evaluation and recommends the State Historic Preservation Officer approve and forward the nomination; Ms. Vivian seconded the motion.

b. Northfield Graded School, Northfield

Devin Colman presented the Northfield Graded School in Northfield for consideration for listing in the National Register of Historic Places. The building is commonly known as the Gray Building. This is a Preservation Trust of Vermont Paul Bruhn Grant related project. Polly Allen served as the qualified professional.

The Period of Significance is 1876 to 1974, recommending listing under Criteria A and C, with Education and Architecture as the Areas of Significance. David Skinas inquired about Criterion D for the granite works (which has a VAI# but was further down the hill) and remnant of the earlier school; a spearpoint was found.

Paul Carnahan made a motion that the Northfield Graded School in Northfield meets the National Register Criteria for Evaluation and recommends the State Historic Preservation Officer approve and forward the nomination; David Skinas seconded the motion.
