VI. SHPO Report

Ms. Trieschmann updated the council on the following:

- Flood disaster coordination with FEMA is increasing both for the impacted State Historic Sites and historic and cultural resources statewide. Emergency reviews are being processed in coordination with VTrans and Federal Highway Administration for culverts and bridges, some resulting in adverse effects.
- State historic sites have closed for the season, which was successful; final tabulation of visitation and income will be provided.
- Federal fiscal year ended September 30 and end-of-year reporting pending; will be shared in January for discussion at March annual meeting.
- Historic Preservation Grants will be provided for review by the council on November 17; 38 applications were received (one does not meet criteria and one rescinded by applicant).
