Presentation by Kate Frederick: She has written on the Land Grant Act that was written by Justin Morrill. (www.landgrabu.org). The Justin Morrill Homestead in Strafford, Vermont is run by the state and does not have the background information about the Land Grant Act and how that was used as a so-called land -grab and displaced the Original people when it was used to establish colleges and institutions we have today. Kate asks questions in her writings and is seeking support. kcfredricks@gmail.com A new state "Historic Sites Chief" will be looking into providing more information at that site that gives the whole history. The University of Vermont was given land originally to build the institute under this law.

OLD BUSINESS

8. Native Legislative Caucus 2023 discussions, bills in motion

Discussion was had on some of the bills from the weekly meeting of "Legislative Caucus" run by Rep. Sims. The Tribal Tax Law is being looked at. (passed 2022) Changes to trapping laws have been tabled. Effort to amend the tobacco law to include use for spiritual practices is being added.

9. Meeting with Governor Scott 3/8/23 – Report

Meeting with Gov. Scott included the Proclamation for Abenaki Heritage Week to be the first week in May. Chief Joanne Crawford and from Suryanarayana, Shalini (she/her). In regard to the Abenaki Recognition and Heritage Week," I just submitted a Proclamation to the Governor's Office Our hope is that it will be released at least a week before May 1. Also, I understand that the AHS Abenaki Equity Workgroup that Joanne Crawford leads will be hosting a few events during the month."

10. Act 182 (2022) Land Access & Opportunity Board report

Dan Coutu is the new representative for LAOB, Land Access and Opportunity Board. Dan tells us that the Vermont Land Trust is mapping land use and access on their properties.

11. Act 142 (2022) Racial Justice Statistics Advisory Council (Stacy Gould)

12. Act 154 (2022) Environmental Justice Advisory Council

Environmental Justice Advisory Council slowly starts with meetings next month.

13. Act 174 (2020) "Vermont State Parks - Abenaki signage" status
