## 1. Department of Children and Family Services Update

Marshall Rich and Lindsay Barron made a presentation about their work that included sending out 150 notices that placed three children with kin in Vermont and identified nine children with Federally recognized Tribes. Tribes could be more involved with DCF although there is a trust issue with some tribal members. This program is set up for the well-being of all "Indian Children". One suggestion is to create a liaison committee that would support Tribal parents.
