#### 1. Commissioners and guests introduction and sign-in

The guests introduced themselves.

#### 4. Commissioner's annual priorities, goals, & suggestions

#### **OLD BUSINESS**

#### 1. Reminder: Ethics certifications for Commissioners

Communicated to all Commissioners.

#### 2. Act 182 (2022) Land Access & Opportunity Board report (Dan Coutu)

Dan provided an update on an RFP posted by the LAOB for an equity assessment of housing and land programs in the State of Vermont.

#### 3. Act 142 (2022) Racial Justice Statistics Advisory Council (Stacy Gould)

No updates. There was discussion about the Commission reaching out to better understand the RJSAC's work and timeline.

#### 4. Act 154 (2022) Environmental Justice Advisory Council

Rich relayed that they have had one meeting and are in the process of writing the guiding policies for the council. Rich noted that they will be putting out an RFP for a mapping tool, and guests shared the importance of accurately tracking the number of Native people in the state.

# 5. Act 174 (2020) "Vermont State Parks - Abenaki signage" status

No official update, but guests shared a VT Fish & Wildlife announcement about the new Awasos Wildlife Management Area. Discussion ensued about various informal signage collaborations throughout the state.

#### 6. Act 128 (2022) VT Truth & Reconciliation Commission -TRC (Melody Mackin)

No official update, but Rich shared that there are ongoing meetings the 2<sup>nd</sup> Tuesday of each month. Brenda and Dan shared that the committee has started to meet. Guests shared the importance of sharing and knowing the history of eugenics in VT so that all communities can reconcile and heal.

#### 7. Act 152 (2022) Nondiscriminatory School Branding/Mascots – Status

No update.

#### 8. Act 33 (2021) VT Health Equity Advisory Council (HEAC) Ongoing

No official update.

# 9. Act 126 (2023) Community Resilience & Biodiversity Protection - focus groups (10 min)

Rich shared that there will be an initial report next month.

#### 10. Seventh Generation Curriculum Grant Committee report (Jeff Benay)

Jeff shared that to accommodate for the unexpected interest in printed materials, the project has had to seek additional funding sources. He also shared that they will be seeking community input soon. He reiterated the rollout date as Indigenous People's Day 2024.

#### **NEW BUSINESS**

#### 1. Assign secretary duties and VCNAA point of contact to Admin Director

A motion was made, 5 Commissioners voted in favor, two absent from the vote.

### 2. Appoint Breanna Sheehan to 250th Commission as VCNAA representative

Vermont 250 Commission appointment was transferred to Breanna Sheehan. A motion was made, 5 Commissioners voted in favor, two absent from the vote.

#### 3. Sowing Seeds: Vermont statewide conservation conference

Discussion ensued about the need for an Abenaki presence at the conference. Rich shared that an Indigenous led coalition has submitted a panel proposal. Guests echoed the need for Indigenous representation in these spaces.

#### 4. Status report on Commissioner terms, reappointments, and open seats

Breanna shared an update on the status of current Commissioner term expiration dates, upcoming reappointments, and filling the two open Commission seats.

#### 5. Admin Director onboarding update and summer project brainstorm

Breanna shared an update on the status of her onboarding and asked for suggestions for projects to take on while the Commission is on their summer break. Commissioners and guests offered their thoughts and suggestions.

- **Nulhegan**: Dan shared that Nulhegan is planning some Cultural programs and are seeking instructors/teachers. Chief Stevens shared that he will be making a trip to New Zealand soon and the tribes should let him know if they'd like him to share a gift on their behalf.

- **Elnu:** Roger shared that Elnu recently has their annual Shad fishing outing in Turner Falls. Breanna shared that Elnu is also starting to put on cultural programs.
