#### NOTE:

- The Sole Proprietor Stabilization Program will be managed by Brattleboro Development
  Credit Corporation (BDCC) and Two-Rivers Ottauquechee Regional Commission (TRORC)

   both entities have recent considerable experience with the Agency managing disaster
  recovery program (CDBG-DR) funds totaling over \$12.5 million. If the State of Vermont does
  not receive the Waiver approval of Direct Assistance, the Business Assistance Program will
  be subgranted to TRORC and BDCC, respectively through appropriate municipalities as a
  grant award from the State.
- The Housing Stabilization Program (per eligible activity regulation 24 CFR 570.207 (b)(4) Income Repayments) will be managed by the 5 homeownership centers that qualify as Community Based Development Organizations (CBDO) which are the only organizations eligible to provide mortgage and rental assistance through the CDBG program.
- Allocations are estimated based on the State's CDBG-CV Award.
- The Agency reserves the right to adjust fund categories by up to \$100,000.
- Recaptured funds will be reallocated as soon as feasible.
