

## Vermont Department of Housing & Community Development Mobile Home Park Registration Summary

Vermont home park owners register their parks annually and pay a registration fee of \$12 per occupied leased lot. The fee is used for mediation and legal expenses related to lot rent disputes, maintaining the mobile home park database, and administering the mobile home park law. Every three years, the department publishes a comprehensive Registry and Mobile Home Parks Report.
