# **BEGAP Informational** Webinar Presenters



## **Program Overview**

The Business Emergency Gap Assistance Program (BEGAP) is a grant program for businesses and nonprofits that suffered physical damages from flooding events. This includes farms and landlords.

Funding is for property damaged in the 2023 and/or 2024 floods. Eligibility and grant calculations differ depending on several factors.

BEGAP funding is granted per physical location, and separate applications need to be submitted for each physical location.

A business or nonprofit can receive grants for up to three physical locations, per flood. (Ex. If a business or nonprofit received BEGAP funding in 2023) for three properties, and another property was damaged in 2024, they could receive BEGAP funding for that fourth property.)

# Important Information for All Applicants

A cell phone is required to open an application account.

It is essential that applicants remember their login email and password.

BEGAP funding is taxable.

Private nonprofit organizations which provide services of a governmental nature and are deemed critical should apply directly to FEMA for uninsured disaster-related expenses and/or disaster-related damages to the facility. (Ex. Emergency services, water supply, electric power, telephone communications, direct medical care.)



# BEGAP Eligibility Requirements for All Applicants

This information applies to all BEGAP funding.

An eligible applicant for BEGAP must be a business or nonprofit that meets the following criteria:

- Physical property damages must be in Vermont.
- Physical damages include damage to real estate, leasehold improvements, inventory, machinery, and equipment.
- Intends to reopen in the same location or elsewhere in Vermont and will utilize the grant funds for this purpose.
- Nonprofit organizations providing community service (education, utilities, health care facilities, or emergency services) that were denied a Public Assistance Grant from FEMA.

## The following are ineligible:

- Municipalities
- Businesses or nonprofits that sustained only economic injury (revenue loss)
- Individual homeowners (for home-based businesses, this application only pertains to business assets)
- Nonprofit organizations that provide community service (education, utilities, health care facilities, or emergency services) and receive a Public Assistance Grant from FEMA.



#### Deadline

Applications are due November 15, 2024

## Eligibility

- Business or nonprofit must have been established before the 2024 flood(s).
- The location for operations and/or assets must have suffered physical damages from the 2024 flood(s).

#### Grant Calculation

- 30% of net uncovered damages, up to \$100,000.
- . "Net uncovered damage" is the remaining unmet need after subtracting any insurance proceeds and other grants or donations used to defray the costs of repairing or replacing damaged assets.

## Note

- · Preference will be given to applicants with the majority of their operations based in Vermont.
- 10% of funds will be set aside for awards to Black, Indigenous, and Persons of Color applicants.
- Applicants who received funding for 2023 flood damage are also eligible to apply for new damage sustained from 2024 flooding.

- Damage type and estimated costs for repair/replacement

#### Required Documentation

- · Profit and Loss Statement if the business started recently or if the most recent tax return is unavailable
- An updated IRS Form W-9
  - · Please Note: Documents must be hand-signed in blue or black in within the last year. Digital signatures will not be accepted. The address must match the mailing address listed in the application.
- . Declaration or Certificate of Insurance for all policies held
- Supporting documentation for claimed damages (insurance adjuster report, vendor estimates)
- · Repair estimates for physical structures, equipment, inventory, supply purchases, or actual paid expenses
- · Photographs of damaged property (maximum of 5)
- · Proof of interest in the damaged property (e.g. property tax bill, deed, lease agreement)



#### Deadline

• Applications are due September 30, 2024.

## Eligibility

- Business or nonprofit must have been established before the 2023 flood(s).
- The location for operations and/or assets must have suffered physical damages from the 2023 flood(s).
- The applicant has not already received 2023 BEGAP funding for this property.

#### **Grant Calculation**

- 30% of net uncovered damages, up to \$50,000.
- "Net uncovered damage" is the remaining unmet need after subtracting any insurance proceeds and other grants or donations used to defray the costs of repairing or replacing damaged assets.

#### Note

• 20% of funds will be set aside for awards to Black, Indigenous, and Persons of Color applicants.

- Proof of interest in the damaged property (e.g. property tax bill, deed, lease agreement)

# Supplemental 2023 BEGAP Funding

Please use the application form to submit an initial inquiry. If the inquiry meets the eligibility requirements, applicants will then receive an application via email.

#### Deadline

Inquiries are due September 30<sup>th</sup>, 2024

#### Eligibility

- The business or nonprofit received 2023 BEGAP funding and has ongoing unmet need.
- The previous BEGAP award must have been less than \$500,000.
- The business or nonprofit must have 50 or fewer employees.

#### **Grant Calculation**

- Up to \$50,000.
- A pro rata calculation to determine amounts will be confirmed following the close of the current round of 2023 BEGAP applications.
- The calculation will be the total funding that remains available (following the close of 2023 Supplemental BEGAP applications on September 30, 2024) divided by the aggregate unmet need of applicants.

#### Note

20% of funds will be set aside for awards to Black, Indigenous, and Persons of Color applicants.



## Technical Assistance

All applicants seeking assistance in preparing to submit this grant application, including translations, can receive help from the Central Vermont Economic Development Corporation (CVEDC). CVEDC is the statewide technical assistance provider for BEGAP. Fill out their support request form and they will follow up with resources to help.

## Required Documents

Upload documentation to support the physical damage to your business. Documentation must be uploaded that supports ALL claims of monetary damage for which you are seeking assistance.

## Required:

IRS Form W-9: This must be signed within the last 6 months in blue or black ink (non electronic signature). \*

Most recently filed Federal Tax Return (or 990 if non-profit) or if you do not have a filed tax return upload your most recent profit and loss statement. \*

Further, I understand that intentional misrepresentation of information is fraud and may subject me or my organization to disqualification from receiving further benefits, administrative penalties, and criminal prosecution. Any person who knowingly presents a false claim for payment to the State is at risk of criminal prosecution including up to five years imprisonment and a fine of up to \$10,000 and may also be liable under the Vermont False Claims Act for up to three times the amount falsely claimed plus a penalty of \$5,500 to \$11,000. *

7. Applicant acknowledges and agrees that BEGAP funds, and any and all information obtained by the State from the Party in connection with this applicand grant award are subject to the State of Vermont Access to Public Records Act, 1 V.S.A. § 315 et seq. *
