#### Work Tasks • Municipal Vulnerability Index • Toolkit

- Toolkit Discussed how work would progress with different projects. Connecting specific tools with people who can help towns navigate the tools, curate the list so towns can access easily. Hazard Mitigation team can help in putting it together. Looked at creating a subgroup to work on a buildout on this toolkit; Ben Rose, Caroline Massa, Karen Horn, Ann Lawless and Jens Hilke will work with Marian.
- Municipal Vulnerability Index GMP expanded the index to include other key indicators on resiliency, communications, and social vulnerability. Funds are set aside for consultant assistance to put together for the Council. Jens brought forward the resiliency plan is more than just the hazard piece outside of the GMP work. Minimum datapoints, identifying what needs to be measured is part of the piece on what equals vulnerability in Vermont. The technical analysis budget was discussed for developing an RFP to build the Municipal Vulnerability Index. A cross committee subgroup would be used to measure progress and report on the RFP process.
