#### 1:30 PM Convene/Welcome/Overview and Approval of Agenda Kristin Clouser, Agency of Administration & David Plumb, Consensus Building Institute

# 1:35 PMReview and Approval of December 1 MinutesDavid Plumb, Consensus Building Institute

Minutes were approved by the Council with the following changes suggested:

- In the discussion of the final text:
  - Add in "human impact such as mental health, air quality, and heat waves".

#### 1:40 PM Just Transitions Reflection – Exercise around Public Engagement Improvements David Plumb, Consensus Building Institute

David Plumb led a discussion on the Council's ideas for future public engagement for the new year. Key points of the discussion are recorded below:

- Council members suggested resourcing trusted community organizations that are known and understood by community members. This type of community organizing should be done in a way that this a part of the Council's work, not as a "fix" by others to where the Council has failed.
- In terms of communication, the Council should proactively explain what the plan "won't do" in addition to "what it will do", to reduce fears and get ahead of rhetoric.

- The Council should reach out to groups that are not just the organizations typically consulted, and who represent a broad range of Vermonters.
- There was a suggestion to do deliberative polling for public engagement.
- The Council should focus on who is doing the synthesizing of information and feeding it back into the Council's process.
- The Council should reflect on its process. (The council should expect a survey and a future council meeting to have this reflection.)

#### 2:00 PM Overview of ARPA Dollars Doug Farnham, Chief of Operations (Invited)

Doug Farnham from the Agency of Administration gave a high-level overview of ARPA dollars and their potential uses. Key points from the subsequent discussion with Council include:

- Is it okay to think broadly in terms of how funding can be used for resilience?
  - Doug said yes, but there may be a need for additional justification, and you will need to find the link to how it is benefitting a disadvantaged community in order to have flexibility with funding.
- Can you explain more about the categories of eligibility?
  - Doug explained that there are normally qualified census tracks that have automatic eligibility, but in Vermont there are very few. The state has used income-based metrics that will identify a community as disadvantaged. These standards have proven to be useful for eligibility.
- A question was asked about infrastructure upgrades.
  - Doug clarified that general infrastructure projects are not allowed except for broadband, sewer, and water. If an individual is impacted by COVID and in need of assistance, there is a possibility of infrastructure projects related to the building the individual lives in.

Julie Moore, Jen Hollar, and June Tierney gave presentations on ARPA Investments related to water, broadband, and housing respectively.

# **3:00 PM** Discussion of Process for Allocating ARPA Dollars Jane Lazorchak, Director of Global Warming Solutions Act

Jane Lazorchak presented on the process for the Council related to allocating ARPA dollars. Afterwards, the Council had the opportunity to discuss the types of recommendations for the

allocation of ARPA dollars as well as the process going forward. Key points from the discussion are recorded below:

- Council members had a discussion on the criteria for recommendations. Frequently repeated criteria were: impact on climate goals, equity, leverage, and cost effectiveness.
- In terms of **equity**, Council explored the ideas a minimum percentage of funding going to frontline or marginalized communities, like the State of New York as well as the Justice 40 initiative from the Biden administration.
- In terms of **leverage**, members of the Council envisioned ways that funds could be used to create an on-ramp for future actions.
- Members of the Council suggested some emerging priorities in terms of ARPA dollar allocation. These ideas included: home weatherization/upgrades, EV charging infrastructure, and water/waste-water. A suggestion was made that the Council can provide guidance to trusted partners putting in work in such areas.
- Council members suggested that recommendations on allocation should be kept at a high level. These recommendations should be thought more as guiding principles. When making recommendations, members of the Council suggested to take into account the needs and experiences of the whole state.
