4:07 PM Climate Council Updates

- Legislative initiatives 12 key bills, wrapping up in the next week or two, point of discussion at next full climate council meeting
- Eight task groups working on specific areas—Jane acknowledged that major pitfall is the State's inability to pay stipends at this moment
 - o Transportation & Biomass task groups do not have JT representation
 - Most other task groups are focused on implementation or meeting statutory requirements
- Next full Climate Council meeting in May 16, then not again until the Fall

Updates from Various Task Groups & Work Groups

- Public Engagement update from Kashka
 - Met with Vt Council on Rural Development to share notes on ways to engage authentically and learn from each other
 - Working with partner organizations to connect with marginalized communities
 - Jane shared the council has \$60K for ongoing engagement work, in addition an RFP for ongoing engagement work and ongoing facilitation of Council work
