Overview: This is the second meeting of the re-constituted Ag & Eco Subcommittee, tasked with helping the Vermont Climate Council update the state's Climate Action Plan.

The overarching goal for this subcommittee for the next 5 months is to review the 150+ Ag & Eco strategies and actions in the Initial Climate Action Plan, consider key changes in the context from 3 years ago, then prioritize the strategies and actions, to better focus the attention of policy makers, the administration, and others. The initial plan has great content. Let's use that content as the basis for highlighting the most pressing strategies and actions.

By late fall this year, we aim to share with the Council a list of highest priority strategies and actions, no more than a few dozen, plus the identification of a handful of strategies that might make a top-10 list for the overall updated Climate Action Plan.
