### \$1M Expansion of the Water Quality Assistance Program (FY25 state budget)

- The Vermont State Legislature appropriated \$1M in the State Fiscal Year 2025 budget to provide financial assistance to logging contractors to ensure implementation of practices that protect water quality on logging sites and that help loggers adapt to climate change. This financial assistance is an expansion of the existing Water Quality Assistance Program that has previously provided skidder bridges to loggers.
- The FPR Division of Forests has held two meetings with logging contractors to get input on what
  types of practices should be covered under this pilot program and how the funding should be
  structured to ensure flexibility as well as the right balance between a simple and rapid process to
  obtain the funds and adequate accountability to ensure the use of funds is achieving the
  program goals.
- FPR will hire a service provider to award funds to loggers based on a straightforward application process and a schedule of accepted practices with unit costs, and we hope to have the program up and running for the winter logging season.
- Funds can also be used to support the costs of Master Logger Certification, a third-party
  certification for loggers that demonstrates compliance with applicable laws and regulations
  regarding protection of employees, professional harvest planning, and the application of logging
  techniques that protect soil and water resources, cultural heritage, wildlife, and forest
  aesthetics.
- FPR will submit a report to the legislature on the results of this pilot program by July 15, 2025.
