# ANR RULEMAKING – ACCII, ACT, HD OMNIBUS, PHASE 2 LOCATION OF PUBLIC HEARINGS & TIMELINE DRAFT

## **LOCATION OF PUBLIC HEARINGS**

For rulemaking, ANR is required to comply with the Administrative Procedure Act and the Global Warming Solutions Act (GWSA) which states:

The Secretary shall conduct public hearings across the State concerning the proposed rules. The Secretary shall conduct a portion of these hearings in areas and communities that have the most significant exposure to the impacts of climate change, including disadvantaged, low-income, and rural communities and areas.

To determine the location of the public hearings, ANR is considering the following sources:

- The *Guiding Principles* developed by the Just Transition Subcommittee.
- The <u>State of Vermont Climate Action Plan Public Engagement Plan</u> developed by Climate Access and Rise Consulting for ANR, July 2021.
- The <u>Community Engagement and Communications Strategy</u> developed by the Vermont Climate Council which calls for proactive steps for engaging a broad range of people on climate action.
- The <u>Vermont Climate Action Plan Public Engagement Findings</u> developed by Climate Access, Rise Consulting in partnership with ANR.
- Act 154 of 2022 (S.148), Act relating to environmental justice.
- The EJSCREEN 2.0 tool developed by the U.S. Environmental Protection Agency.
- The <u>Climate and Economic Justice Screening Tool (CEJST)</u> in development by the U.S. Council on Environmental Quality.
- The <u>Vermont Environmental Disparity Index (VTEDI) Overview (arcgis.com)</u> developed by the University of Vermont.

Based on this information, the following "areas and communities" in Vermont may be considered to "have the most significant exposure to the impacts of climate change, including disadvantaged, low-income, and rural communities and areas":

- Rutland or Bennington
- Burlington North End
- Bellows Falls or North Brattleboro
- Newport, Orleans County

**Before July 11** – Finalize public meeting schedule with locations

July 11 - ICAR review and hearing

July 15 - File proposed rule with the Secretary of State's office (see publication timeline below)
