Climate Action Office (CAO)

- Supports a vision for climate action across state government.
- ❖ Works closely within the Agency of Natural Resources and across state Agencies to understand the actions state government are taking to make measurable progress to meeting the requirements and goals of the Global Warming Solutions Act.
- Coordinates and provides significant expertise and capacity on state-led climate initiatives, as well as the monitoring, assessment and tracking of climate adaptation, mitigation, and resilience activities.



CAO Inter-Agency Advisory Board

- Inform State policy and the direction of State Agencies related to issues related to climate change.
- Foster intra-State partnerships, as well as with governance entities external to State government in pursuit of effective delivery of climate change solutions for all Vermonters.
- Identify and frame up gaps in climate action being delivered across State government where the CAO might prioritize support.
- Agree upon prioritization of the specific resources and capacity of the CAO to advance the most pressing needs as determined by the IAAB in support of State Agencies.
- Ensure that programmatic functions of the CAO are additive and supportive of existing climate action work across State government.
- Articulate where policy and financial implications overlap around climate action to ensure resources are maximized.

Measuring and Tracking Progress

- Issue an RFP for the first phase of a measuring and tracking progress tool to compile and visualize data and metrics related to adaptation and resilience related activities and for mitigation strategies for reducing GHG emissions in Vermont.
- Develop meaningful metrics to understand the adaptation, resilience, and mitigation strategies being implemented in Vermont. Additionally consider metrics around community engagement.
- Development of a CAP action tracking tool to rollout with state Agencies.

- Additional funding to support community engagement contract and facilitation services, as well as translation services
- Significant resources for contracted services and technical analyses update
- Sub-grant to RPCs to support outreach to municipalities and alignment of energy plans updates with CAP
- IAAB Members reviewing CAP Action Status and prioritizing state actions for PCAP consideration
