- Jared Duval shared the current status of drafting responsibilities for the Climate Action Plan, including due dates and lead authors.
- Discussion of the timeline for chapter drafts, with a focus on the March 1st deadline for submission to the Climate Action Office.
- Ken Jones raised a question about the relationship between actions and outcomes, emphasizing the need for analysis on the effectiveness of past strategies.

- David Grass discussed the scope of the health chapter, noting the challenge of comprehensively inventorying health benefits from mitigation actions.
- Lesley-Ann highlighted that the climate and climate change section involves contributions from multiple subcommittees, including rural resilience and adaptation, and agriculture and ecosystems, to ensure a comprehensive perspective.
- Lesley-Ann emphasized the importance of making the Climate Action Plan accessible and relevant to the public, addressing feedback about its implementation and ensuring it is clear and actionable.
- Lesley-Ann clarified that health and well-being aspects are being integrated into the health chapter led by David Grass, while economic aspects are being incorporated into Ken Jone's chapter, to streamline the document.
- The group agreed to hold two meetings: February 14th to review chapter drafts and February 28th for an update on emissions reduction pathways analysis and the business-as-usual (BAU) baseline assessment
- Jared Duval will coordinate the sharing of drafts by February 12th for review before the February 14th meeting.
