All licensed, registered, and approved relative child care providers who wish to be paid child care financial assistance (subsidy) on behalf of families must submit child care attendance reports in the Child Development Division Information System (CDDIS). Visit the [CCFAP Information for Providers website](#) for CCFAP resources, CDDIS trainings, and contact information.

Attendance must be submitted in two-week intervals called service periods to receive CCFAP payments. Attendance must be submitted after the end of the service period. Attendance entered after the service period and before the submission deadline will be paid on the pay date indicated in the chart. Attendance submitted after the submission deadline will be paid on the following pay date. CDD issues payments in between regular pay dates for late attendance entries for prior service periods and attendance adjustments.
