Welcome	Member and attendee introductions (name, role, and organization)	
STARS Team Progress Report	 STARS applications This month STARS has received 7 new applications: 6 NAEYC or Head Start and 1 Registered Family Child Care program. In total, STARS has received 21 applications: 6 Head Start, 5 NAEYC, 3 provisional level 3, and 7 non-affiliated. STARS training updates The STARS team co-presented with the SPARQS team at VTAEYC's annual conference on November 7, 2023. STARS overview and CQI webinar trainings offered on October 13, October 26 and November 8 have received consistent attendance and engagement. The next webinar on CQI planning is scheduled for November 29. More training sessions will be scheduled for late December and January. STARS team presented to Building Bright Futures and Vermont Afterschool Field Forum in October. Upcoming STARS presentations are scheduled for Addison County and Franklin Northeast Supervisory Union. STARS staff updates CDD has hired the Child Care Quality Program Administrator (STARS Administrator). Courtney Isham will start on December 18. She is a former County Supervisor for Head Start, CLASS assessor, and most recently served as Associate Director at the Sara Holbrook Community Center. 	
SPARQS Update	Vermont Afterschool, Tricia Pawlik

	 Vermont Afterschool has received 8 requests for assessments, most of them very recently. One assessment is already completed, and the others have been scheduled based on program availability. Tricia noted that programs may benefit from reminders that assessments should be completed several months before programs' STARS certificates expire in order to demonstrate progress on CQI goals. Jacek confirmed that during the pilot year, programs may not have significant time between receiving assessment and submitting a STARS application and are eligible for a 90-day extension from their assessment date to submit their application. Tricia and Sonya noted that the Youth Thrive Survey is designed for children aged 12 – 26, older than children in Vermont Afterschool programs. They suggested the survey may be adapted for younger users. Tricia also suggested the DESSA mini tool, citing its use to measure social emotional learning may not be ideal. This item will be added to next month's Advisory agenda.
	SPARQS, Nichole Bearor
	 SPARQS has received 118 requests for CLASS assessments via their online portal and are assessing and scheduling each based on programs' STARS expiration date and request date. SPARQS will begin offering CLASS training to programs via Zoom starting in late January. Nichole reviewed the assessment strategy for multi-age, multi-site programs. Amelia explained Northern Lights' plans to support Communities of Practice (CoP) for PD credit and to provide technical support to CoP facilitators.
	Adapting CLASS assessments for short-time programs
	 Questions from programs that run 5 hours or less prompted STARS to ask Teachstone and SPARQS about adapting CLASS for shorter assessments for these programs. Nichole confirmed that accommodation.

	STARS Attrition and "quality vs finance"	
	 Advisory Group members discussed several barriers programs expressed or members identified that may prevent engagement in STARS: Significant level of change ongoing in the field; programs are too understaffed or overwhelmed to embrace the revision, home-based programs are traditionally less likely to engage in QRIS, the revision is complex, and the administrative burden too great. The question of financial incentives is linked to CCFAP reimbursements Attrition can be mitigated with robust and positive outreach, clear communication to programs and families about STARS from CDD and all resources (SPARQS, NL/Resource Advisors, BTAP, ECE Networks). Communications should highlight that STARS is an effective and supported tool for increasing program quality. Improving quality is what programs already do. Reminder that all licensed/regulated programs are STARS participants. Program may engage more fully in STARS whenever they are ready. Resources to support involvement and success are being rolled out.
