# FFY2022 Funding Update:

#### **Council Name Selection Standing Rules**

This document explains the process of how our new name for the Council be selected. Members should review this document prior to the start of the discussion.

Prior to the meeting, these six names were pared down from the original list of over 15 potential names:

Council on System-Involved Youth Vermont Council on Youth Justice Council on the Vermont Youth Legal System Equitable Justice for Youth Council Reclaiming Justice for Youth Council Vermont Youth Equity Council

#### **Step 1: Preliminary Straw Poll**

These six names will be inputted into a Zoom poll at the beginning of the discussion. Council members shall cast one vote for their top choice. If any names do not get any votes during this straw poll, they will be removed from further discussion. If one name has unanimous votes, the Council shall continue discussion on that name.

#### Step 2: Discussion of Remaining Names

Four questions will guide discussion on the remaining names from the Straw Poll:

- Does this name stand for what we're working for?
- Does this name describe the work we do?
- Can the public read our name and understand what we do?
- Can you (as a member) remember our name and do you believe the public can?

Zoom polls will be published for each remaining name with these questions. Council members shall respond to each question with a Yes, No, or Maybe response. Council members may decline to respond to the question.

Council members may verbally discuss their thoughts in the midst of voting.

### Step 3: Second Vote

Remaining names will be inputted into a new Zoom poll where Council members shall cast one vote for their top choice. Any names that did not receive any votes shall be removed from further discussion.

The council shall discuss any lingering thoughts about the remaining choices. If one choice receives unanimous votes, that name shall become the Council's new name.

### Step 4: Final Vote

Remaining names will be inputted into a new Zoom poll where Council members shall cast one vote for their top choice. The choice with the most amount of votes shall be the new Council's name.

# Move to accept the standing rules for decision a name. Seconded. All in favor. Passed. Unanimous.

- After the first poll, we deleted the "Reclaiming Justice for Youth Council" there were no votes
- Justice has never been equitable for black/brown people.
- Isn't the use of both equitable and justice redundant?
- Noticing that a large amount of the conversation was focusing on the word equity/equitable, and that there is a large interest in using those words in our title.
- Council for Equitable Youth Justice? slightly different version of Equitable Justice for Youth Council
- Are we confusing the word/concept justice with the existing justice system?
- Concerns about the public understanding what equity means
- The same concern applies to the word justice many people understand "justice" to be punishment

At this point, with 4 new names on the table, a new poll was taken

- 1. Council on Youth Justice 17%
- 2. Council for Equity in Youth Justice 33%
- 3. Council for Equitable Youth Justice 25%
- 4. Council for Youth Justice & Equity -25%

After eliminating a Council on Youth Justice, another poll was conducted.

- 1. Council for Equity in Youth Justice 8%
- 2. Council for Equitable Youth Justice 75%
- 3. Council for Youth Justice & Equity -17%

Motion for "The Council for Equitable Youth Justice" to be the new name. Seconded. All yes, unanimous, passed.
