Office of Economic Opportunity:

HOP SFY2026 Application Review Update

- 1. Timeline, Process, and Budget Overview
- Thank you to applicants for their continued patience during the HOP SFY2026 review process. We are in the process of finalizing budgets, issuing award notices, and working on grant agreements.
- Received 43 applications, totaling approximately \$42M (not including client financial assistance).
- The total budget is approximately \$32 million, including an increase of \$3 million to sustain shelter projects started in SFY25.
- As many of you are aware, ERAP Housing Stability Services, a COVID-19 era funding program, ends June 30, 2025, and the HOP budget is not generally able to absorb requests to maintain positions currently supported with ERAP HSS funds.

2. Shelter Maintenance & Expansion Update

- Shelter capacity for 114 households will be maintained (started midyear in SFY25) or created in SFY26. This includes capacity for 68 households that we anticipate coming online during SFY26.
- Seasonal shelter capacity is anticipated for 42 households this year across three
 projects, but we are working with Vermont Interfaith Action to develop new
 protocols and processes around Extreme Weather Shelter. More information will
 be shared later this summer, including information on how communities will be
 able to apply for funding to support this work.

As the Executive Order is set to expire on June 30, 2025, the program will no longer utilize the Medically Vulnerable form or associated review process.

The chart below outlines the current eligibility categories for households scheduled to exit the program between June 23 and July 1, 2025:

Eligibility Date Calculation:

The 80-day limit is based on a rolling 12-month period and does not reset on July 1.

Nights are calculated by conducting a 12-month lookback. This means that if someone applies on 9/15/25 ESD will calculate how many nights the client was housed between 9/15/24 and 9/15/25 excluding cold weather. The 12-month look back changes each time a client applies.
