Housing Opportunity Grant Program COVID-19 Supplemental – Phase 2

State Fiscal Year 2021¹ (July 1-December 30, 2020) Program Summary

The Office of Economic Opportunity (OEO) awarded over \$3.5 million in supplemental funding in State Fiscal Year 2021 under the Housing Opportunity Grant Program (HOP) to support COVID-19 related costs at 29 non-profit community organizations in Vermont. These funds met the immediate need for expanded essential services and housing navigation services to exit and re-house families and individuals experiencing homelessness and in motels due to the COVID-19 public health crisis.

Approximately \$3.2 million was expended due to delays in hiring as well as challenges in finding staff for short term positions. A summary of outcomes and investments follows:

- 27 agencies expanded outreach and onsite services to households in motels, 1,141
 households were served. Of those, 17% (191 households) moved from homelessness to safe
 housing.
- 18 agencies provided housing navigation services² serving 1,810 households. 249 of those household were rehoused in stable permanent housing.
- Over \$220,000 was invested to create mental health support service capacity on-site at
 motels to support homeless individuals and families. 7 agencies participated in this effort,
 serving 9 of the 12 AHS Districts. 171 households were referred and of those households
 connected with a mental health support person, 92 connected with ongoing mental health or
 substance use services.
- 3 agencies established new landlord liaison projects in 4 AHS Districts to support rehousing efforts.
- Emergency shelter providers utilized these funds to add staff capacity and procure supplies such as HEPA air purifiers and personal protective equipment as part of COVID-19 mitigation efforts.

These efforts were implemented in conjunction with programs such as the ESG CARES Housing Project, which provided over 375 new housing rental assistance vouchers, and the Rapid Resolution Housing Initiative, which provided flexible financial assistance to assist households in exiting motels.
