RELEASE OF LIABILITY: Personal property worth more than, or with a replacement cost greater than, \$50 retained in the possession of an inmate is the responsibility of the individual. I, the undersigned, Doe, Janey, hereby agree to release, hold harmless and forever discharge the State of Vermont and the Vermont Department of Corrections from any and all claims, demands, liability, right or cause of action of whatsoever kind of nature which I may have, in any way arising from or in any way connected with any property losses or property damages in excess of \$50.00 for any single item of personal property that I retain in the correctional facility.

The Vermont Department of Corrections shall not be responsible for the repair or replacement of retained personal property lost, stolen, damaged or destroyed. Furthermore, in the absence of negligence the Department shall not be liable for damage to personal property which may result from staff inspection of such property, notwithstanding any other provisions in this form. When an inmate is required to relinquish control of personal property to the Department, the Department shall become responsible for safekeeping of the property.

STATEMENT OF RESPONSIBILITY TO SAFEGUARD PROPERTY: The Department of Corrections will provide a safe area with appropriate security to protect any stored property. At the time of your release or disbursement of property, it is your responsibility to check property against your property receipt. If any of your property is missing, you must notify the releasing officer and request a Report of Lost or Damaged Property Form.

I, Doe, Janey, certify that the items listed above are the personal property items that I own which have entered the correctional facility or have been released, disbursed, or disposed of by the correctional facility, as indicated. I have read this release and I agree not to hold the State of Vermont or its employees responsible for any items of personal property which I voluntarily bring into the institution for my personal use while incarcerated except as otherwise provided herein.
