could hold someone um criminally accountable for violating the open meeting law that's not going to fix someone's underlying accessibility issue though that's going to that's going to compel

in each municipality um just because we're we're not trying to just deal with those specific issues

and I think as Kate mentioned in the comments like it changes from day to day disability is

39:52

the thi is a thing um that touches everybody and it's it's it's one um you know uh category of you

know a class of people that changes regularly because every single one of us um could become

40.11

disabled at some point in our lives it's not like um other disabilities that you're born with and

40:19

you know that's just the way that your life is going to be i mean a car accident could could

40:25

change anything for any of us and so that number is going to constantly be changing so trying to

identify a a a class of people in the here and now um to in order to create uh rules and

laws that are going to be longstanding on the books um it doesn't make a lot of sense to do

i think I'm gonna suggest that we I'm having trouble keeping up with the chat that is very

substantive as well as the the conversation and I want and I think there's a lot of important stuff happening in the chat over there um that is not so I guess my request is let's use the chat for

um when they're coming to this and a lot of well-meaning people are going to be 42:37

concerned about making mistakes concerned about um ways of talking about these things and I think finding finding a way to to to

start at the beginning like Megan was saying is going to be really most useful especially for putting something out there for public use as well as legislative recommendations

does that does that sort of summarize I think where where we where we're at um okay yes Megan

one of the things just if if it's useful to you that Lauren was doing was just reading the chat

so that it was part of the public record so we can do that let me pull it up here i was Let's see

so what we have in the chat of substantive we have Kate's list we have let's see I think we okay so

we have from Kate some of universal design can also be practices and procedures for example a

with election officials the month before and day for um meetings would be universal design

then we have some more guidelines from Cynthia um Kate noted that legal aids um CAP program is that

the consumer assistance program okay yeah um has links to resources they frequently use and that's

44:15

affiliated also with the attorney general's office for universal design and printed materials um so

44:21

we should be looking there um and then Kate says "Stability is dynamic and what's true today may not be true tomorrow and even with one individual what is needed as an accommodation today might be

44:30

different tomorrow." Um and then Laura said "Yes that's ableism." Exactly we're trying 44:35

to avoid and I think that's like starting with a normal and then moving to like what's not normal

44:41

as opposed to thinking about the the whole like scope uh you know and starting starting

44:46

from the from the full landscape um yeah and Laura also mentioned at the beginning and this

is Andy which I thought I was adding to that no level of foreseeable accommodations will enable every person to engage at the level they want to without specific practices i'm honestly confused

do you want to say any more about that Andy at this point or do you think we moved on or would you like do you want to add to that um I I think it's it's really tough to design in a way that

45:16

gives everyone as much engagement as they could want without them asking and the the thing that

45:23

we heard that like none of these practices will necessarily uh meet that goal and so if 45:31

it's a balancing test and really what we need to do is say you should always be captioning

45:38

you should make hearing devices available if you've got a meeting and you expect a greater

45:45

population than this if if we can boil this down to a set of practices that's great but I 45:53

think the idea that that we can meet everyone where they are without knowing where they are

um it it makes my head get a little a little explody but I think Frank had his hand up yeah um

as far as undue hardship is concerned that is with the Vermont state open meeting law however

46:23

the Americans with Disability Act as of as Laura may be able to testify to as expanding in in the

46:29

case law to also include those in the autism spectrum in some cases all right so you have

46:36

a civil problem here which I there was somebody running around we had an office and was we had we

46.45

put out handicap ramp and had the door sizes not everybody did but there was actually some people

46:51

running around seeing what places did not have handicap access hunting for a civil case location

that I experienced in my past and I met these people and that's what they were doing and they're going from village to village looking for people that didn't have handicap access in

47:10

order to engage with a civil action i thought that was interesting you know hunting for some cases

47:16

uh so you have that and one of the things that technology-wise that we had to me ask answer

47:25

some of our questions that I mentioned that put in the spreadsheet Megan with the over was the

47:31

uh everybody has these cell phones these days and if they can come into a meeting like we're

47:37

doing here virtually with the hearing devices attached to the cell phone they would be very

47:42

well able to audit the meeting without without having hearing devices or having simp hearing

47:50

devices that would be readily available that would be like those types of devices so I think that we

can get past this but the requirement that has to be done is something we were trying to deal with

with inclusive factor is we're not excluding and so uh the question really is if if the state wants

to set up a statute where accommodation would have to be pre-erequested and if that would be

in this in this matter right um except we know that like basically no because the de facto is

that you're going to have to like just do a lot of work as a disabled person at the end of the day you're still not going to get what you need to have access to meetings and you're going to be

universally hated in your town you know um so like I really I don't think it's in this particular

case I don't know that it's actually useful to think about universal design in the framing of

people with disabilities because think about for example the towns who have spent a lot of money to

install elevators are those elevators ever turned on do they know where the locks are for the doors no um but it's not just people with wheelchairs who should have access to that it's the mom with

the stroller right and so like if we can think about this as access for all I think it's going 50:33

if in fact the accessibility transparency and accountability and act 133's charge is for everyone because like captions for example like you shouldn't have to have any sort of diagnosis

to be able to request captions like I might be a parent holding a sleeping baby in my arms and want

50:49

to be able to engage in the meeting and still get access to captions without being told no

50:58

john yeah I I like I think you have some really good points there Ken thinking about broadly for

everyone yeah my mind's been sticking back with those questions about I think were popped up I

think Cynthia or maybe NDS2 with with the surveys and my thought is you know for the survey if it

thanks i I perhaps this has already been shared in previous meetings but like I gosh I I want to

I want to just name this concept of people like hunting for civil rights violations is like not

really a thing because it's not necessary to hunt every disabled person I know has had civil rights

57:41

violations right um and I have like at least in my in the peers that I work with at BCIL I know

57:47

20 people like 20 different towns who have been denied access to public meetings in the last year

57:52

um some of them very rudely um so there's not there's not the need I don't think we should be

57:57

afraid of this concept of hunting for civil rights violations because like they're there in every single town um and just by just by virtue of the fact that how many towns is it right now 75 that

58:09

do voting floor voting for public options local elected officials or budgets just by virtue of

58:15

that already um 173 at least are um systemically excluding people so and we have our federal laws

58:24

we also have our state laws that protect um the rights of people with disabilities um and those

58:30

are only as laws are great laws are only as great as the enforcement mechanisms the enforcement mechanisms are horrible and the people and the organizations that are able to do the three and

58.41

four and fiveyear fights um like lawsuits are not fun they're awful actually they're really awful and very expensive um and they never get any they don't really result in what people like basic

58:51

rights at the end of it um those organizations are also being defunded left and right so I really

58:58

do want to push back that in my understanding of Act 133 is not about access accountability

and transparency for disabled people it is for anyone in Vermont that wants access and so if that means that I am a town voter registered voter in Arlington but I want access to a town meeting

telephone does that mean telephone could cover it i just I just I'm pretty sure it does but

and the goal that's listed there about not overt taxing meeting leaders um is that where where does

that goal language come from i made it up um what I was and what I was trying to do there

was create and maybe taxing is the wrong word but um what I was trying to do was do talk about the

sort of two polls that we're talking about and it was essentially the the ones that Jenny mentioned earlier how do we support and include everyone and also acknowledge that that calls on

that this particular guide this particular element that we're discussing today um the best practice

becomes is it possible to set up the text so that there that can be filtered out ahead of time

uh where it doesn't even get into the general discourse or to the record because it's a big

1:42:45

problem getting it out of the record out of the out to edit it out and that's being de dealt

1:42:52

with as Laura is well that's in a bill yeah um it is a problem and but it's a problem it has been

1:43:01

a problem in a traditionally all public meeting in person as well so um but just with technology

1:43:08

documenting it and keeping it forever for the duration of time potentially or for a month um the

1:43:16

legislature uh tried to tackle that by allowing um redaction for certain specific purposes

it's very specific but if there's something in the tech where you could figure it out ahead of time that would be wonderful yeah i don't know if there's a tech ability to do that but yes

do you have any Laura any examples of that that might be helpful to put into

Well like braille to braille to speech might be one oh well I guess that provides for hearing but

um or braille to uh text to speech or um

yeah I mean I'd have to think a little bit more about about what those sort of

um peripheral device you know peripheral uh communication devices might be but

um not using one myself i I'm not exactly familiar but

one question that I have is just like who is the definer of the things um and the default continues

to be the town clerk or the select board members and I know that like this is not a place really for examples but I often I'm constantly thinking of the examples me and my peers have experienced

and so I just want to give one um this was a city a large city like this was like the like one of

the top largest cities in Vermont so this is not a resource issue um two years into COVID um there

1:49:45

was a group of community activists who wanted to share public comment at a city council meeting for

something that they cared deeply about they showed up there were like 15 people at public comment amazing guess who didn't like it the select board members they did not want to hear from 15 people

about that issue concerned about it and so one of the city council members um had said during that

1:50:06

meeting that the meeting quality was very bad and they looked forward to all of these rules ending

that required hybrid because they quote couldn't wait for those same people to be there in person

1:50:19

look them in the eye and make that comment like it was so I just want to be really careful when we

1:50:25

talk about meeting quality that it is not defined by the systems that are making things inaccessible

we're talking about sausage making i'm not sure how to put that in the notes Kate maybe if there's No it was just Yeah

1:50:47

it was just a reaction to um so Susan had some like generally Yes i agree with the offer of the

1:50:53

um the wording that acknowledges inherent tensions and Susan wrote goal is to improve accessibility and transparency while maintaining meeting quality and adequately

resourcing communities to do so like whenever we put in a caveat the question then becomes

1:51:08

who defines that caveat and I will tell you time and time again I know who's going to define that caveat and it's not going to be the people who want access to meetings mhm

lot or are um feel like they've done something wrong because they haven't followed the rules

of the road and I think um good public bodies sort of read the room about whether the their

1:52:52

rules are reasonable um and should be doing that yeah and thank you for that and just to

1:52:57

be clear this was an example where all rules of public comment were 100% followed the city

1:53:03

council members were just very angry that people had the audacity to be able to join online and share a public comment when they should have been sitting in front of them under their

1:53:11

scrutiny yeah well that doesn't sound uh at all appropriate nor does it sound um responsive to

1:53:22

the concerns that are in front of them but that intimidation happens in small towns and with

1:53:30

uh so-called able-bodied people as well um and it just it's it's who you have in leadership

1:53:37

and what the flavor of that leadership is is going to determine how um inclusive it's going

1:53:46

to be and that seems like that's the elephant in the room you can make all the rules you want in the world but whether or not they're willing to follow them is something quite completely

different and we have a very divisive time right now that's pushing in the wrong direction

i see a couple more hands up that is it Susan's next on here and then Frank um 1:54:14

what is read at the start of every meeting and might be posted on our website too so 1:56:42

my understanding about that language is that it derives from model rules put forth by the Vermont League of Cities and Towns which is a number organization for their municipalities um

board members their members that meetings are meetings of the public body you know and it is
