training for public bodies um you know that our working group is responsible

6:11

for making recommendations on trainings uh for public bodies around compliance

6:17

with the open meeting i will note that um there is a training requirement um

6:23

that the secretary of state provides training and that certain members of public bodies take that training um but

6:31

um I would be interested in the perspectives of those who are not in our office how is that training um and also

6:39

do you think that there needs to be more

6:52

is any has everybody attended one of the training sessions well there's there's the training

6:59

sessions that we're doing when we're asked but there also is a video that's available on our website which is how

7:05

the Secretary of State is providing the training um we have provided a video that anyone can watch at any time and

7:12

certain members of um groups are required to do that by law

7:19

sue thanks i was actually going to sort of ask the same uh question i know um the

7:27

video is available on your website but I feel like um

7:33

there may there may be people that don't understand that that video is the training

7:41

i thought there was a disclaimer that it wasn't no that's probably the league's video is

7:48

my guess the League of Cities and Towns also has their own set of open meeting law trainings that are not statutoily

7:55

mandated but that they offer their members on all kinds of topics including the open meeting law um and I know they

8:01

have their disclaimer on there saying "Hey this isn't this isn't the one that the statute requires same as they do for

8:07

their ethics training." Um but the one we have on our website is the one that act 133 required of our

8:16

office to provide which is an annual training for a subset of state and local

8:22

officials so this is self enforced self enforced by those who are required

8:28

so there's no tracking correct that's right under statute

8:35

i think probably some towns my guess would be that some towns are tracking and some towns are not

8:47

i just did the ethics training uh which is required every 3 years and I thought was excellent uh that video training and

8:54

and uh the frequency of the questions within it was great the uh summary at

8:59

the end was excellent okay a separate matter but also uh SOS

9:06

online training delivery uh well no we didn't do that um Oh sorry

9:13

that's all right no too that's It's the Vermont Ethics Commission that does that one that's right um Yeah yeah and they

9:20

have one for the state and they have one for municipalities

9:25

but if that's a great one that's a model you know yeah

9:34

as a suggestion if the legislature still wants to have enforcement is that they

9:40

would have provide to those who they are requiring it some

9:47

level of a log and for to to track

9:52

because there's no method of tracking right now enforcement would be under the

9:57

general enforcement provision of the open meeting law so someone could theoretically file an open meeting law violation complaint that had to do

10:07

with that how how that would play out I haven't thought through yeah just as

10:12

this but

10:20

I also wanted to let the group know that education law requires

10:25

schoolboard chairs and their superintendent to do um eight hours of training annually together and there are

10:33

several topics that need to be covered in that training and one of them is open meeting law

10:38

so we do provide that in several different um formats

10:44

and sometimes with us association sorry and some and sometimes with us yes

10:50

yes thank you very much and how is that how's that enforced

11:00

it is not enforced as far as but provided proactive but

11:06

provided proactively and very much encouraged yes so it's Yes it's the

11:12

carrot it's the carrot not the stick

11:17

yes Cynthia i could test uh one town's tracking by simply asking as a member of

11:24

the public if they have taken their training see what happens when they ask that

11:30

yeah yeah that's that's a good idea

11:36

what is the plan for tracking or is that being done

11:50

that's a per year training correct yes yes annually

11:59

and there was discussion during the legislative session about if there should be tracking or if there should be

12:05

logging and um I will tell this group very candidly like I did the legislature

12:11

there was no money given to the secretary of state's office to build this training or to build the um online

12:18

capabilities so I can tell you that we will not have a login um because that requires software uh and um we could

12:27

possibly have a certificate that people could print out at the end um but even that is has some technical things that

12:35

um we uh don't have a budget for and um would

12:41

need to build so if the concept is that we are responsible for providing proof

12:46

of um attendance and tracking and all of those things then we'll have to talk

12:52

about what that means in terms of logistics and budget and

13:00

uh Megan and then Frank and I I raised my hand i did not mean to

13:05

interrupt you no it's fine it's good the um I'm wondering if just if have you

13:12

heard anecdotally from folks that have watched it has it brought up any questions or clarifications

13:20

that you want to ask you know sometimes people just like anytime they attend our trainings will

13:26

come with the specific question about how this applies to their specific scenario

13:31

you know that I mean in terms of feedback I haven't heard anything negative i haven't heard any substantive

13:40

suggestions either that doesn't mean that that's it's not possible to improve upon and it hasn't been brought to my

13:45

attention specifically i've heard

13:52

I've heard anecdotally that the the Secretary of State training is is uh great i think people have appreciated it

13:59

and um I I do think this is something um Andy and I can also ask the League of Cities and Towns staff because they talk

14:06

with I mean Secretary of State's office does as well um but both of them get phone calls and talk to municipalities

14:12

all the time uh so yes Cynthia can ask in that um but my guess is that there's

14:18

something maybe even more comprehensive that we that we can do if we want to get feedback and I would love to hear how

14:24

the league what the league is advising municipalities on in terms of compliance like are they recommending that um this

14:32

be centrally logged or um I would love to hear what their

14:37

recommendation is frank at CE courses

14:43

um for education which is needed for lenture in a lot of cases there's a

14:50

documentation process where even in the middle of the meeting of the presentation there's a popup where you

14:56

have to respond so you're not like leaving your computer running and going off and doing gardening while you're I

15:03

think I think we all have been part of that type of training and that's exactly what I was saying Um that's the gold

15:10

standard that is the gold standard and um our office made very clear to the

15:16

legislature last year that that gold standard was not accomplishable without funding because that requires that

15:23

requires more than what we h we don't we don't provide this in any other space

15:29

and um so we don't have a software application to build into it nor the technical capabilities to to do that um

15:37

so if that is the expectation that would just be a conversation it's not I'm not saying it's not possible um but that is

15:45

if that is the expectation of this group or of the legislature then we'll just have to talk uh explore and then talk

15:53

about how we would make that happen um and I can tell you it probably would be

15:59

we need some money so that we can hire a contractor to to help us build that um

16:05

and software to help us build that because that's a deviation from our standard practice

16:11

even the video I mean it was great but we hired a contractor we did not have

16:17

money allocated to that purpose and um we spent I don't know probably

16:24

I don't know how much we spent but we we definitely paid somebody else to help us build and record that that video and

16:31

edit that video you know in order for it to be good there needs to be some

16:36

editing and some um it needs to be professionalized which is what we paid

16:42

somebody to do um and we did that without an allocation from the legislature so if we're talking about um

16:51

Oh thank you Megan um if we're talking about you know um expanding the the role

16:57

which I think we should um or at least you know what that would look like um I

17:02

just want to be really clear that we would probably need some money just like we're going to have I think money is a

17:09

whole I mean it's a whole topic on our agenda because I think we're going to flag lots of places where there's lots

17:16

of good ideas but without money to support it it's not um fair to expect it

17:23

so of the three or anybody else wants to do the technical stuff I think that should

17:29

be on our agenda as a technical issue because money is often times related to

17:34

technical um so we can include that how's that sound Andy

17:42

megan um I Well go ahead i Please go ahead Susan well I was just going to say

17:48

in addition to that um I I agree that it's really good to understand what the technical options are i also think

17:56

we need to understand that just because we can do something technologically doesn't mean that it's the answer and

18:02

that oftenimes I mean in order to get people to attend and take in trainings um we need to make them

18:11

make it clear why they should want to um because you can attend and stare at it

18:16

and and resist everything that comes in technical isn't the only answer the answer has to be how do we create a

18:22

culture of interest in inclusion interest in accessibility interest in

18:28

open meetings um so again it's the it's the carrot and stick uh quality

18:35

the easier the interface the more people are liable to use it keep it simple

18:40

stupid is really the the part of it and and if people want to attend the meetings you can give out an award of a

18:47

free tour of the Secretary of State's office

18:53

good point Susan

19:08

um any other thoughts on training

19:19

i will tell you that um one of the secretaries of one of the secretary of

19:25

state's goals is to go to provide an in-person training a hybrid in-person

19:31

training in each county um but we um have not done that yet um so um but I do

19:42

want to let people know that is part of our goals um Cynthia

19:48

what about the idea of uh providing training for an aspiring uh board

19:54

members as well we have a or even like people who are going to be moderators or

19:59

something we have a new moderator who's never done it before and she would benefit from it if she knew how to

20:05

access training also anybody who's um wanting to apply for the job is up

20:12

against an uphill battle against an incumbent because they don't know how to do it but the person who's there already

20:17

will always win it because everybody knows them unless they blow it um

20:23

they're not likely to be replaced by a new person i guess I'll say the Secretary of

20:28

State's trainings are available to anyone just like we give um general information education to anyone on open

20:36

meeting topics and public records and municipal um any member of the public can take ours it's on our website

20:42

whether or not everybody knows that is a different question um but and then and also our inerson trainings that we have

20:48

done um in the past we have done ones that are just open to anyone yeah we

20:54

would yeah not make them closed sessions ever so maybe some

21:01

Oh sorry sorry just so maybe some uh in uh including some announcement that hey

21:06

if you want to you don't have to be a member of uh one of these boards in order to make use of them because I

21:13

don't think people really know that yeah

21:21

um Susan then Frank yeah I was just going to say as a model

21:27

um I remember when um Vermont's town reports the municipal town reports were just all over the map sometimes they

21:32

were just like crappy little mimographs sometimes they were you know color you know and did they include the things

21:38

that were required in in the statute in terms of the uh financial documentation and I think it was the extension system

21:44

that um and the town officer education training um uh created a an award system

21:50

um and where you got like you know this one was you know blue ribbon quality and you know and um so that town clerks

21:57

could put in their office you know we we achieved this quality and um that kind

22:03

of recognition is I think I mean we can talk to the clerks and treasures association but the um I think municipal

22:10

officials respond to the a reward system like that I mean who wouldn't we all do

22:16

um and name and so naming the the qualities of accessibility that that towns can uh can offer and making those

22:23

measurable and achievable um it might be one way to to help

22:33

going to put up here

22:38

um Frank yeah some of the smaller

22:44

undo hardship qualifying potentially groups also don't have the bandwidth

22:50

from a personnel perspective as far as redundancy is concerned with this with this type of thing when they have to

22:55

step in at a moment's notice and all of a sudden boom be live be on stage so um

23:02

that's a consideration there too is that not only one person have the training

23:07

but have multiples in the group that require the training which is only right

23:13

now stipulating the chairperson and I think that's what my board is right it's a wider group it's a wider group

it is for the state chair of any non-advisory

23:26

public body for locals it's chair of the legislative body town manager and mayor

23:32

so in some towns that don't have a town manager or mayor it would just be the chair of the legislative body we've so

23:38

the um um they some people have clerks in their

23:44

select boards um and uh so maybe just

23:49

having a couple people that would be statuto you know change it would be

23:55

reasonable I think um and it wouldn't be overbearing

24:00

u to have two because it would aid them in having their meeting because technically if you can't run the meeting

24:05

legally according to the statute is the meeting going to be legal going forward

24:10

well I don't I don't read the statute as if the chair is not available it's an illegal meeting because the vice chair

24:17

didn't take the training but um I do think you have a valid question Frank of

24:22

should the list be expanded um to include more people

24:31

um uh this is a little bit separate from

24:37

open meeting but um I just was thinking along the lines of Cynthia's statement

24:43

um of is there um publicly available training

24:48

on Robert's rules and annual meeting um that the public can watch and that

24:54

someone who is interested in the process can watch um outside of um you know

25:01

someone who has that core responsibility for a town and if so where is that

25:10

does anyone know if that's available or if that's something that should be available

25:17

pretty sure it's not i think all all covered uh groups follow Robert's rules

25:23

that's my my sense is that's up to each one and they're organizing meetings to decide uh the format for the meeting

25:32

okay i'm not aware i think it would be great because there are a lot of people who don't know it um we had a

25:37

parliamentarian on on the Mont City Council we have no such person uh in

25:44

Middbury and they had to run a a meeting that required more formality

25:52

than usual at the local school board recently and they were all over the place understanding what a vote on an

25:58

amendment was and what happened after that happened and it was rather a mess

26:06

um Susan you were going to say something well I was going to say I'm pretty sure that that doesn't exist in terms of what

26:13

you were talking about in terms of an accessible sort of I mean there are there is literally a book called

26:19

Robert's Rules for Dummies um but it's way too thick um the League of Cities

26:25

and Tons does a town moderator training every year they call it the town meeting tuneup and it's super wonky but really

26:30

really fascinating um for somebody like me who likes town moderator stuff but um

26:38

uh they're revamping that now um and so

26:43

um I know it's not the league's charge to create um things for non-municipal

26:48

officials but it might be an interesting um uh partnership um if there was a sort

26:54

of a a simpler version i know the Vermont Institute for Government which is not super active now but um uh

27:03

there's a website that has a lot of materials that were created back when Paul Gillis uh had just left the

27:08

Secretary of State's office and there is a um a one-pager two-sided one-pager um

27:15

that goes on uh the seat at town meeting that explains the basics of Robert's

27:20

rules and so there there are some you know real basic materials that could be um adapted I think company our office

27:27

also has a handbook quite old still decent i mean the the rules are have

27:33

been the rules forever but we have we have a but we have a summary document that was you know and but we but I am

27:38

not aware of any trainings okay um Cynthia is your hand lingering or new

27:44

no new um wacky idea um so there could be professional

27:52

people who are experts in all of the rules and regulations and updates who

27:58

operate as circuit writers um who are supported by all of the

28:04

municipalities to be called in for when there's a new or sketchy um meeting that

28:13

needs to be uh overseen like that would have been helpful in our last town meeting when we fell apart um

28:21

I don't know it seems like if there were people like if somebody knows the rules to a board game really well then they

28:27

become the authority on what the rules are and you can turn to them when you're confused and keep the meeting on track

28:34

just I mean I think I think that there so just so you know Cynthia I think that

28:41

is how the LCT would see themselves um as advisors to towns in that scenario

28:50

but whether or not municipalities take come up on it is a whole other matter um

28:55

and do they come to me

29:01

wow okay they provide I mean I don't think I'm over my skis there Andy and Susan

29:08

right doesn't Doesn't the league provide advice to towns on how to run town meetings

29:15

they do a big training and they have staff they have an open a 1-800 line

29:21

that's open uh during town meeting uh they don't close up shop entirely um I

29:28

think that when a town has a specific problem I mean they respond to th to those um but you know I mean every

29:36

community every organization in the world um sometimes gets in over its head and realizes they should have some

29:43

figured something out before before the meeting so I'm I'm not sure that they uh I don't think they have a fast squad i

29:50

guess is that would be cool wouldn't that be cool

29:55

or just say "We have a new group meeting and we have no clue could you come in and tutor us through the first time

30:03

in real time as we're having the meeting rather than a training ahead of time

30:09

which is um uh theoretical

30:17

Yeah sorry i just got distracted by a legislative issue there are some brief

30:23

pieces out there i used them and I was in the leader positions in some

30:29

environmental organizations and and it was confusion as to how to operate and I

30:35

think you the a lot of towns have policies and operational procedure meetings for stuff for meetings and they

30:42

could easily be given guidance as to how to update that on a per town basis and how they want to mend it according to

30:48

their town that would be easy to do in writing

31:01

okay i don't feel like we have a clear answer on D at this moment um

31:07

but I do hear Cynthia's request to provide more

31:15

information to the public in a clear and concise spot um I would say that

31:22

probably the Secretary of State's office would be the place that if there was a training on Robert's rules we would put

31:28

it on our website because we are not an association um and so that's you know a lot of times

31:36

all the associations do really great work but it's only accessible to people who are part of it um and so but we

31:43

would be great if we if there is an interest in creating those trainings if we could do it with the league um and

then put it on our website and again you know the the concept of money and

officials and and perhaps something broader than just Robert's rules the procedure for

town meeting right because because it's a bit broader than rules so

32:31

I said um Robert's rules and town moderation should I expand that Jenny

32:37

well I think you know we have Oh you can't see my notes oh I'm sorry oh you can oh yeah oh yeah um I I would

32:45

say you know because there's some statutory language for town meetings that differs from Robert's rules that would override we have I mean I think

32:51

it's just the some of it's just the the traditional aspect of people not knowing where to sit or how to you know to feel

32:58

like how to speak you know there's some colloquial language i don't know there's all kinds of things that I think would help make people more comfortable in

33:04

that space that is outside of Robert's rules okay

33:09

i I definitely think that's true i just want to be clear that I do think that a lot of that training and we're just

33:16

we're we're talking about should there be a training for the a training for the public i think there is one that um um

33:23

for for municipal officials maybe it needs to be expanded so this says "Should there be training for the public

33:29

or interested municipal officials?" There is one for municipal officials um

33:34

right but that's after you've become one and I think what Cynthia's asking for is I'm interested in running for select

33:41

board what does that mean for me um and Susan I don't think that person would

33:47

have access to the LCTs is that right Cynthia

33:53

or um or aspiring municipal officials maybe

33:59

aspiring okay that would be great yeah that that makes sense

34:08

and when I suggested trying to get a couple of our towns around and we're me members so we should be able to get that

34:16

training and when I tried to ask for it everybody kind of poo pooed that idea

34:22

so maybe it's just a lack of interest

34:29

uh Frank I have a generic question how many towns do we know of that have

34:35

websites and how many don't is there any data on that i think Sean

34:41

do you know that by any chance because of the elections work

34:48

every town in Addison County has a website uh some of them are incredibly static and out of date but I know that

34:55

there is a a page for every town in Addison County yeah I think as far far as statewide I

35:01

could look at our CFR um that's one of the questions we have town clerk survey

35:07

let me let me follow up on that because what could be done as a

35:13

suggestion brainstorming is that if there's a web page that has hyperlinks

35:19

out to recommended training and advisory things whatever then then the public

35:26

would have access to that at any time and could be directed to it at each town's website

35:35

and that can be updated because the hyperlinks could be changed as time went along as opposed to having every town

35:40

change their websites which might be a problem yeah

35:46

and I don't think it's every if it's every town in Addison County i don't think it's every I think there's definitely towns in the Kingdom and

35:52

other parts of the state that don't Yeah don't have websites i did not survey every town in the state

that's come up with some of the things we've asked them to post that's definitely come up that some some don't

but we'll try to get a number

susan uh and Sue do you guys see the And actually Sue can can you send a copy

about this it could be a piece of our civics budget um and civics program but

um I know that there was I don't remember

42:27

how much money was spent on that project but it was not inexpensive even though it was done uh with a lot of
