Electronic Records Day – 10/10/15

How are YOU managing digital records?

This year marks the fourth year celebrating <u>Electronic Records Day</u> sponsored by the Council of State Archivists (CoSA). It is a great



opportunity to reflect upon how we use and care for our digital records. Electronic records offer Vermont state and local officials unprecedented ease of creation, search, and retrieval of information. Yet digital records are in many ways more susceptible to damage than paper records, and their long term preservation requires attention and planning.

This year, for Electronic Records Day, review your organization's records/management policy and ensure that it is both up-to-date and includes specific guidance for electronic records. Be especially mindful of new initiatives or programs that have incorporated digital services. If your office has no plans for preserving electronic records, or is lacking a records management policy, contact us at rim@sec.state.vt.us and we will help you through the process of developing one.

Summer 2015 Confirmations a Success

Records Officers and Liaison Designations and Appointments Confirmed

Each summer, VSARA goes through the process of confirming and updating all of the state's Records Officers and Liaisons.

We do this for several reasons: staff turnover and changing personnel, concern over the security of records in the State Records Center, and as a tool for reaching out to all state, agencies, departments, divisions, and courts to gently remind them that they need to manage their records. This summer we successfully confirmed 51 Records Officers and 520 Records Liaisons. The confirmation process resulted in the removal of approximately 100 individuals' access to state records, while granting about 50 employees new access to their department's offsite records.

If you know of a position change or staff turnover, you do not need to wait until the annual confirmation process to notify VSARA. We can update our database at any point in the year: just send us a new <u>Records Officer Designation</u> or <u>Records Liaison</u> form. Finally, this process could not have been accomplished without the assistance of all the Records Custodians, Records Officers, and Records Liaisons; thank you for helping us ensure the continued security of Vermont's records by participating in the confirmation process.

Origins of the National Archives and Records Administration

A little more than 80 years ago, in June of 1934, President Franklin D.
Roosevelt signed into law the National Archives Act. This law established the first National Archives charged with managing the Federal Government's records. The Federal Records Act of 1950 expanded the National Archives responsibilities to include semi-active records. This led to the development of NARA's modern Records Management Program.

Right to Know Database

Ever had a patron or member of the public request a record and wondered if it was exempt?

To help municipalities and agencies comply with the mandate to provide access to public records for inspection, use, and copying VSARA has developed the Right to Know Database, a searchable index of Vermont's public records laws. This database is a great place to start if you are unsure about providing a requested record.
