## MEMORANDUM OF UNDERSTANDING BETWEEN THE GOVERNOR AND THE SECRETARY OF STATE OF VERMONT REGARDING ARCHIVAL STORAGE OF GUBERNATORIAL PAPERS.

The purpose of this Memorandum of Understanding is to establish clear guidelines to govern public access to "the official correspondence of the Governor," upon the deposit of that correspondence in the custody of the Archives of the Office of the Secretary of State (hereafter "the State Archives"). 1

—The basis for these guidelines is a commitment, shared by Governor Howard. Dean,

M.D.("Governor Dean") and Secretary of State Deborah L. Markowitz, to openness and accessibility of state government, coupled with a recognition that certain gubernatorial documents are exempted from the Right-to-Know law under the constitutionally-based doctrine of executive privilege.<sup>2</sup>

The only guidance provided by the Vermont statutes is that, upon retiring, the Governor is to deposit "the official correspondence of the governor... with the secretary of state," 3 V.S.A. § 4(a), who, in turn," shall... permit the public to inspect, examine and study the archives of his or her office: provided that any record placed in the keeping of the office under special terms or conditions of law restricting their use shall be made accessible only in accordance with those terms and conditions," 3 V.S.A. § 117(a)(2). The statute does not define "correspondence."

In <u>Killington</u>, Ltd. vs Lash (February 16, 1990), the Vermont Supreme Court drew upon the Vermont constitution, as well as upon common law precedents, to hold that the Governor of Vermont may assert "executive privilege" to preserve "the confidentiality of intergovernmental documents reflecting advisory opinions, recommendations and deliberations comprising parts of the process by which governmental decisions and policies are formulated," Slip Op. At 8-9, quoting Archibald Cox, Executive Privilege, 122 U.Pa.L.Rev. 1383, 1410 (1974). The Court held further that documents encompassed by "executive privilege" are, by definition, not "public records" but, rather, are excepted from the mandatory disclosure provisions of the Right to Know law as "records which, if made public pursuant to [the Right to Know law] would cause the custodian to violate [a] statutory or common law privilege," 1 V.S.A. § 317(b)(4). See Killington, Slip.Op. at 11.

The guidelines strike a balance between the desire, on the one hand, to preserve a full and complete record of Governor Dean's Administration for the benefit of future historians and the public's right to know, and, on the other hand, to respect the public policy reasons to deem certain gubernatorial documents privileged under the Vermont Constitution and common law. Specifically, the guidelines affirm the public's right to access to all of the Governor's official correspondence, even those exempted from disclosure, while at the same time setting the date for access to any executive privilege documents within the official correspondence to commence ten years hence.<sup>3</sup>

The period of ten years was chosen as a reasonable but brief period in comparison to the "executive privilege" closing periods used in other jurisdictions (e.g. up to twelve years federally, see the Presidential Records Act, 44 U.S.C.S. § 2204(a); twenty years for the official papers of former Governor Thomas H. Kean of New Jersey (1982 - 1990), see Guidelines for Access to Governor Kean's Official Papers; and thirty years in Maryland, see Policy of the Hall of Records Commission regulating the Use of The Gubernatorial Files).

VT STATE ARCHIVES

- I. Subject to the special terms and conditions of restriction set forth in paragraph II, below, Governor Dean's official correspondence shall be open to the public, in accordance with the established policies and practices of the State Archives.
- Any portions of Governor Dean's official correspondence determined by Governor Dean to be encompassed by executive privilege shall be open to the public, in accordance with the established policies and practices of the State Archives, commencing on January 10, 2013. Prior to that date, the following special terms and conditions of restriction shall apply:
- Governor Dean's executive privilege documents shall be under the custodianship of the Archives and may be housed and preserved pursuant to appropriate archival standards by the State's Department of Buildings and General Services, or any successor agency or department, in files that have been sealed and appropriately labeled and cross-referenced by the Governor's Office (the "sealed gubernatorial records").
  - B. Governor Dean's executive privilege documents shall be accessible only:
    - Pursuant to a valid court order; 1.
    - In accordance with written authorization from Governor Dean; 2.
    - 3. To the staff of the State Archives in so far as necessary to assure archival security; or
    - In the event that the document has been placed in the public domain. 4.
  - C. When Governor Dean's executive privilege documents become open they shall be reintegrated with Governor Dean's official correspondence within the Archives.

D. The Secretary of State and the Commissioner of Buildings and General Services shall notify the Attorney General of the State of Vermont and make all reasonable efforts to notify Governor Dean in the event of a request in any form for access to sealed gubernatorial records and shall defend the privilege and the seal agreed to through this memorandum. Governor Dean shall be given the opportunity to participate in any litigation over access to his sealed gubernatorial records.

Governor Dean and Secretary Deborah L. Markowitz join in this Memorandum of Understanding.

## **Biography**

Howard B. Dean, MD, was born in New York City on November 17, 1948. He graduated from St. George's in Newport, RI in 1966. He received his B.A. at Yale University in 1971 and his M.D. at Albert Einstein College of Medicine in 1978. He then moved to Burlington and commenced his residency at Medical Center Hospital. He married Judith Steinberg, a fellow student at Einstein, in 1981. They have two children.

Dean first became involved in politics in 1980 while volunteering his services to Jimmy Carter's re-election campaign. This experience led to other political connections and Dean became chairman of the Chittenden County Democratic Committee. In 1982, he ran successfully for the VT House and was re-elected in 1984, serving as assistant minority leader. He ran for Lt. Governor in 1986 and won. He served as Lt. Governor from 1987 - August 14, 1991 when he was sworn in as Vermont's acting governor on the death of Governor Richard A. Snelling. He was subsequently elected to five additional terms as Vermont's governor. Dean ran unsuccessfully for the 2004 Democratic presidential nomination. He was elected chairman of the Democratic National Committee in February 2005 and served until 2009. In 2009, Dean entered the private sector after thirty years in public service.

Governor Dean was a strong advocate for equality and human rights. He signed into law several controversial bills such as Act 60 (1997), the Education Funding/Property Tax Reform Bill, and Act 91 (2000), the Civil Union Bill. An advocate for the environment, Dean was a leader in founding the VT Youth Conservation Corps and the Long Trail Protection Fund. He was also a strong voice in the state's acquisition of the Champion Lands in the Northeast Kingdom and in maintaining AMTRAK's "Vermonter" commuter rail service.

## **SCOPE & CONTENT**

Governor Dean's records total 252.2 cubic feet. Of those, 80.4 cubic feet were closed under executive privilege until January 10, 2013. In total, the records document the interaction between the Dean Administration, other government agencies, and the public. They reflect the concerns of Vermonters in general and the public's expectations of the role of the governor.

The records are divided into two sub-groups: the initial records made available in 2003 (boxes A187-00001 through A187-00171) and the executive privilege records opened in 2013 (boxes A187-00172 through A187-00252. The initial records are arranged according to their original order as transferred by the Governor's office. They are primarily arranged according to the structure of Vermont state government, i.e. the Executive Department, the General Assembly, state agencies and departments, and the Judiciary. There are also records concerning the Federal Government and national

organizations (in several of which Dean was quite active). Subject files are included within the agency/department to which they apply. For example, files related to the Vermont Yankee nuclear power plant are found under the Department of Public Service. The contents of each folder remain generally in their original order and the folder titles or subject headings remain as originally given by the governor's staff.

The Executive Dept. records (53 cubic feet) consist of executive orders, proclamations, appointments ("Be-It-Remembered's), pardons, and correspondence files of Boards, Commissions and Councils. The Executive Dept. files also include general correspondence between Governor Dean and his constituents, including various greeting messages and thank-you letters. The Governor's Information Referral Office (GIRO) records, similar to those of previous governors' Action Line files, contain correspondence from constituents with specific concerns, some seeking advice and referral to appropriate agencies. There are three cubic feet of files labeled NRN (No Response Necessary) that consist of incoming correspondence, sometimes flattering, occasionally not, of no apparent need for response.

Other significant subjects include the Agency of Development & Community Affairs, the Agency of Human Services, the Agency of Natural Resources, and the Agency of Transportation. The Agency of Development & Community Affairs files document Vermont's rapid growth and the lack of housing to support it; efforts to create new employment opportunities;, and initiatives to promote Vermont as a business-friendly environment. Agency of Human Services records show how Vermonters have been helped by Human Service programs, or have been failed by the system. The records relate to child care, child support, nursing homes, the correctional system, health care reform, health insurance, alcohol and drug abuse, and hunger. The Agency of Natural Resources records document efforts to balance environmental concerns with increased growth and pollution; elimination of leg-hold traps; and land acquisitions for recreational use. Dean's interest in Vermont's transportation system is evident in the Agency of Transportation files. The records provide insight into the Governor's views on by-pass routes and circumferential highways, as well as alternative commuter transportation.

The Judiciary files may contain correspondence received prior to, during, and after the signing of Act 91 (2000), the Civil Union bill, enacted in response to the Supreme Court's decision in Baker v. State (98-032, 1999). This bill extended certain rights to homosexual couples previously enjoyed only by heterosexual couples.

The federal government records contain correspondence between the Dean administration and Vermont's U.S. Senators, Representative and various federal agencies, as well as correspondence on federal laws, immigration and national emergency procedures.

The executive privilege records include Schedules; Agency Activity Reports; Legislative files; Financial files; and Correspondence and Reading files; and Executive staff files.

Schedules and schedule requests are organized chronologically. The requests include invitations to events, speaking engagements and other requests for the governor's time. His final schedules include information on travel, meetings and public appearances.

The Agency Activity Reports are arranged alphabetically by agency. The reports were submitted periodically by agency/department heads and document the work of each agency as well as relevant policy issues. Many of the reports include Dean's handwritten questions and comments in the margins.

The Legislative files are arranged chronologically and include bill reviews, legislative correspondence and the governor's messages on bills.

The Financial files are arranged in their original order and include payroll time reports, expenses, accounts, bills paid and sole source agreements.

The Correspondence and Reading files are organized by the Governor's Information Referral Office (GIRO) number. These records likely were originally filed within the initial records, but were separated as executive privilege material at the end of the Dean administration. The files consist of correspondence between the governor, his advisors, and the public. These documents were routed to appropriate officials in the Dean Administration using the numbering system. Copies of the final letters were sent back to the Governor, cabinet level officials, staff and/or the public. Topics covered include Health care reform, environmental concerns and post-September 11 emergency preparations.

The Executive staff files include records maintained by some of Governor Dean's advisors. The records include correspondence, reports, and supporting material related to various public policy areas, including energy, housing, and agriculture.
