A note to the reader:

This Director's Annual Report for the Office of Professional Regulation (OPR, Office) covers Fiscal Year 2009 - July 1, 2008 through June 30, 2009. It contains a series of reports from different units within the office, as well as a summary of the activity of the regulatory programs for the 44 professions supported and managed by OPR. You will also find tables and charts providing a detailed report on the activities, revenues, and expenditures for all regulatory programs administered under the jurisdiction of OPR.

Because of the implementation of a new licensing system in February 2009 and the migration of millions of numbers and fields of data from at least three systems into one, this year's annual report pulls data from both the legacy sources and our new system. Our current data is now more accurate and useful than ever before, but we have come across instances where the old data does not reconcile with the new. We have done our best to include accurate information in this report across all systems and through the transitional period.

As we become better versed in the reporting functions of the new system and consistently collect the additional useful data allowed by eLicense, we plan to include more robust reports going forward. Director's Report Fiscal Year 2009

Fiscal year 2009 has been my fourth as Director of the Office of Professional Regulation. An overhaul of our computer licensing system consumed most of our resources for the fiscal year, including an incredible effort from nearly every one of our 30 staff members who were part of the implementation team.

As I reflect on my four years as Director, I see that we have moved forward on a number of fronts, with changes both large and small, all of them critical to a functional office, well-supported licensing boards, and a professional regulation system that achieves the goal of public protection. Some significant achievements include:

- Implementation of the eLicense system
- Consolidation of staff in a professional office
- Active, engaged leadership
- Implementation of standard procedures for licensing and discipline
- High quality and timely investigations
- Improved web pages with more transparency
- Improved inspections program
- Excellent working relationships with legislative committees
- Board member and advisor annual trainings

All of the above achievements, in addition to the many small steps we have also taken, are in moving toward the **TEN GOALS** I have established as part of our public protection mission:

- Goal #1: Efficient, effective and user-friendly application processes
- Goal #2: Easy public access to information about professions and licensees
- Goal #3: Swift, objective, professional and thorough investigations
- Goal #4: A fair, expeditious and well-respected disciplinary process
- Goal #5: Courteous and accessible staff
- Goal #6: A proactive inspections program with a focus on education and prevention in addition to enforcement
- Goal #7: Excellent service and support to empower the Boards and Advisors who regulate the various professions
- Goal #8: Responsible financial management of the budgets supporting the regulatory programs we implement
- Goal #9: Proactive educational initiatives to address public protection issues before they become a problem
- Goal #10: Clear communication about standards for licensure and practice, this office, and its mission

Why Professional Regulation Matters

On any given day, we all use the services of licensed professionals. We trust that our nurses are competent, our pharmacists follow federal law, our real estate brokers are ethical, and our accountants are well-versed in the latest accounting principles, to name a few examples. If you use the services of a chiropractor, cosmetologist, psychologist, dentist, engineer, land surveyor, or real estate appraiser, you've placed your money and sometimes your health in the hands of a licensed professional regulated by the Office of Professional Regulation (OPR).

The goal of licensure is to assure public protection from incompetent or unethical professionals. When professions are regulated, minimal competency is assured. The public is usually spared the distress and practical hazard of

dealing with unqualified practitioners. This is done by assuring that applicants for licensure are qualified, complainants of unprofessional conduct are investigated, and standards of practice are defined. When complaints about licensed professionals are received from the public, the professional regulation system investigates, prosecutes and disciplines the licensee if it's warranted. Disciplinary action against a licensee can include sanctions such as a reprimand, restrictions on the ability to practice, a monetary penalty or even revocation of a professional's license. These actions protect the public and help to cleanse the profession of incompetent, unethical, and dishonest practitioners. It also serves notice on others that Vermont will not tolerate these practitioners.

I have seen and experienced the very real effects of professional regulation. We have investigated and prosecuted abuse of the elderly in nursing homes, pharmacists with substance abuse problems, fraudulent real estate brokers, dentists performing substandard work, tattooists spreading infections with their equipment, and funeral directors converting prepaid funeral funds for their own personal use.

In my 13 years at OPR, I have seen the incredible abuses of confidence and the damage that unethical licensed professionals can inflict upon unsuspecting patients and clients. I have also seen the kind of damage professional regulation can avert and the public protection solution it provides after the fact.

That is why professional regulation is important.

We are fortunate to have so many outstanding licensed professionals in Vermont and I am honored to have worked with hundreds of them in my career. The problem practitioners are truly the exception and not the rule. Professional regulation plays a critical role in helping those professions maintain high standards, and in keeping Vermonters safe.

The Elicense Project

Overall, we spent more than 18 months planning and implementing the eLicense solution. I am proud to report that it has been a tremendous success. Technology projects of this scope and scale have a low success rate. When you factor in that the project team consisted of OPR and Secretary of State's Office staff members with little experience in projects of this size or nature, the odds against success become even more daunting. The team had to clean and migrate millions of bits of data from three legacy systems into the new system and tie them together in a relational database. The team had to envision what the end product would be and then configure the hundreds of thousands of moving parts to make it a reality.

Continuous meetings, countless emails, and many, many late nights added up to a successful "Go Live" of the new system on February 9, 2009. The eLicense system is a giant leap forward in professional regulation for Vermont. In addition to learning the technical aspects of building such a system, we also took the opportunity to analyze our business processes to search for efficiencies. We questioned long-standing practices that no longer made sense. We reviewed the legal obligations for each profession to make sure we were in compliance. We created workflows and revised forms for each of the hundreds of license types we issue. The project has achieved far-reaching improvements well beyond what you'd expect from a new computer program.

We are now reaping the rewards of those many months of hardship. We now have a modern, adaptable licensing system that will serve the office for many years to come, and may become a model for licensing in other parts of state government. Because it is so highly configurable, it is constantly evolving to assist us in becoming more efficient and allowing us to collect and disperse even more information as we carry out our public protection duties.

Those team members from the Office of Professional Regulation and the Secretary of State's Business and IT office deserve to be recognized for their amazing efforts put forth in addition to their regular duties. Their dedication was inspiring at a time when state government is so often criticized.

The Importance of Good Customer Service

As we continue to use our new eLicensing system, we keep identifying areas for improvement. eLicense allows us to automatically generate correspondence, or develop new ways to use email and online applicant status to streamline our workloads. Our goal is to become as efficient as possible to continue to improve our responsiveness and timeliness. We are the gateway to professional practice for some 55,000 licensees and we understand how important it is that we now be an impediment to access to practice in this state and what that means for our economy, our health care system, and Vermont businesses and individuals. Less time spent pushing paper and typing letters means quicker processing and more time spent on customer service.

Providing quality customer service means that we help each individual in a responsive and respectful manner. We frequently have help customers with conflicting interests (complainant and respondent) or customers who are not familiar with the regulations surrounding professional licensure in this state, and so it is often difficult to make the experience a pleasant one. We must constantly balance the needs of public protection with the needs of licensed professionals so that the activities of the licensees are not unduly restricted.


Gratitude
