#### **Director's Note**

The 2025 fiscal year at OPR was significant in many ways.

First, leadership at OPR underwent several changes throughout the year. The previous Director, Kevin Rushing, left OPR in early December 2024. This departure left the director's position vacant at the beginning of a legislative session in which OPR had significant legislative work to complete. I was asked to fill the role of interim Director in early December through the end of the legislative session, which would allow us time to evaluate the future of the OPR director position.

Following the conclusion of the legislative session, OPR's General Counsel Jennifer Colin was chosen to permanently fill the role as the new Director of OPR. Jennifer transitioned into that role on June 30 and with the vacancy in the General Counsel role, we hired Emily Carr (formerly General Counsel for the Dept. of Corrections). We are excited to welcome Emily to our team.

However, Jennifer Colin's transition to Director was actually her second transition within OPR over the last year. Previously the Chief Prosecutor, Jen had just transitioned into the role of OPR's General Counsel at the very end of FY2024. This transition created a vacancy in the Chief Prosecutor role that was filled by Ultan Doyle who was until then the Deputy Chief Prosecutor. Likewise, with Ultan's transition to Chief Prosecutor, Zoe Newman (formerly with the Attorney General's office) was hired as the new Deputy Chief Prosecutor. I am proud of OPR's staff and leadership for maintaining stability and efficiency during this busy period.

During this fiscal year, OPR submitted eight reports to the legislature. Perhaps most notably, OPR conducted a "sunset" review of the Motor Vehicle Racing profession. In accordance with this report's recommendation, the legislature decided to deregulate the motor vehicle racing profession in Vermont as of July 1, 2025. This type of regulatory review is something the Office has a duty to conduct under Chapter 57 (26 V.S.A. §§ 3101- 3108). As far as we are aware, this is the first time one of OPR's professions has been completely deregulated.

Additionally, OPR is in the middle of a funding structure study. The Office is actively examining funding resources, positive reporting data, and alternative expense allocation models, all to address our ongoing budget deficit. OPR filed an Interim Funding Structure Study Report with the legislature, and we expect to submit the final report in 2027 after a two-year data collection period. Some fee changes were made in this session for services the Office was providing at no or low cost to licensees, in accordance with the recommendations of the interim report.

OPR also submitted a regulatory review of real estate brokerage services, a two-year study on licensing in the mental health professions, a sunrise review related to the doula profession, a

sunrise review of early childhood educators, a status report of the regulatory program for residential contractors, and a sunrise review on prescribing authority for psychologists.

Accordingly, this year OPR spent significant time working with the legislature on a variety of new and existing professions. OPR now regulates the profession of *Community Based Perinatal Doulas* through a system of voluntary certification. OPR also supported legislation to regulate early childhood educators. This bill did not make it out of the legislature this year, and OPR will resume these legislative efforts next session. Similarly, a bill for the scope expansion of psychologists to prescribe medication was introduced this year but did not make it through the session and will be placed on next year's agenda.

As of July 1, 2025, I will be transitioning back into my previous role as Chief Investigator. This was a great experience for me personally and provided an eye-opening perspective into all the hard work that occurs across OPR every day. We are all very excited for Jennifer Colin to be taking over as the new Director, and we look forward to the leadership skills she will bring to this position.

Having completed our numerous leadership transitions, we are ready to focus on OPR's priorities in the upcoming 2026 fiscal year. As always, we look forward to working with Vermonters to develop a regulatory environment that improves access for qualified professionals while protecting the public from incompetent and unsafe practitioners.

#### **Organization**

The Office of Professional Regulation, commonly known as "OPR," is a division of the Secretary of State's Office responsible for supporting the regulatory programs for more than 50 professions and occupations – everything from Accountants and Acupuncturists to Tattooists and Veterinarians. Within these professions and occupations, OPR regulates over 170 different profession types and more than 80,000 licensees. The Legislature created OPR as an umbrella agency to oversee professions regulated by both the licensing board and advisor models. Public protection is achieved through a system of licensure and enforcement in which OPR provides three distinct services:

- 1) **Administrative Services** including initial licensure and renewal, public meetings, and regulation and statutory reform;
- 2) **Enforcement Services** involving investigation and prosecutor staff necessary to receive complaints from the public and protect the public from incompetent, unethical, or otherwise unprofessional licensees in the regulated professions; and
- 3) **Tribunal Services** which act in a quasi-judicial capacity for unprofessional conduct or pre-denial of applications.

OPR is headed by a director who oversees a staff of 40 employees including licensing administrators, a deputy director, a general counsel, staff attorneys, policy and system staff, executive officers, case managers, investigators, inspectors, and prosecutors. Regulation assures that practitioners meet minimum competency standards for initial licensure, maintain minimum competency requirements on renewal, and if an investigation finds evidence of misconduct—the practitioner is held responsible for their actions.

## Licensing Trends, Policies, and Administrative Rule Changes

The following graph (Figure 1) demonstrates how the number of licenses issued by OPR has increased substantially over the last several years: approximately 50% since 2015. This growth is attributed to the addition of newly regulated professions, expansion in certain professions, and the transfer of licensure operations from other agencies to OPR.

Despite these additions, licensure trends show a decrease from fiscal year 2022. Notably, staggered growth cycles are common in professional licensure, and OPR usually observes a dip in active license numbers each odd year given the biennial renewal cycle of some of the largest profession groups. However, the implementation of the Nurse Licensure Compact (NLC) is likely responsible for the extraordinary reduction in total licensure during FY23: a loss of approximately 10,000 licensees.




Figure 2: Annual Licensure Data from Fiscal Years 2015 – 2025.

The NLC allows nurses who hold compact licenses from other jurisdictions to work in Vermont without a Vermont nursing license. Consequently, a large portion of Vermont's RN and LPN populations were no longer required to hold a license in Vermont and allowed their licenses to expire at the time of renewal. Additionally, new nurses coming to Vermont with an active compact license do not need a Vermont license to practice in the state. The decision to adopt the NLC was based on the benefit to both Vermont residents and employers: RNs and LPNs with compact licenses can practice in Vermont without delay.

#### **Licensing FY25 Summary**

FY25 was a year occupied by licensure compact approval and implementation. Vermont is currently in the process of implementing interstate licensing compacts for Psychology, Clinical Mental Health Counselors, Occupational Therapy, Social Workers, Physical Therapists, Speech Language Pathologists and Audiologists. The implementation process involves updating statutory language, coordination with the FBI on federal background checks, coordination with the Vermont Crime Information Center, and numerous updates to OPR's licensing software.

OPR is always mindful of finding ways to reduce barriers for professionals to enter the licensure field if they are qualified to do so. In addition to the compact updates, OPR added shop licensure for the professions of Esthetics, Nail Salons and Permanent Cosmetics. Now, licensees who perform these services can hold shop licenses outside of cosmetology and tattoo shops.

Likewise, in FY25, legislation was passed to allow OPR to license individuals without a *US SSN* by allowing applicants to instead enter a valid EIN or Tax ID number.

Moreover, the provisions put in place for licensees during the COVID pandemic demonstrated that Vermont licensees need the ability to meet their continuing competence requirements in other ways than attending "live" continuing education conferences. Consequently, additional statutory changes were made to allow licensees to complete CE through interactive online methods.

The devastating floods of 2023 and 2024 have required the Governor to keep the State of Emergency in effect, which in turn has also maintained the EMGY licenses OPR offers in an active state. Many professions such as Pharmacy, PI & Security Services, Engineers, Architects, Well Drillers, Wastewater Operators, and many of our health care related professions, still have active EMGY licensees and have been working to assist Vermonters through the devastating impacts of the 2023 and 2024 flooding.

Lastly, the Administrative Rules implemented during FY 24 were for the professions of Notaries Public and Peer Support. Extensive work was done on updating the Pharmacy and Dental rules which will be implemented in FY26.

## **Professional Regulation Enforcement Division**

The Enforcement Division of OPR has two Units working together to meet its public protection mandate: the Investigation Unit and the Prosecution Unit. The purpose of OPR's enforcement process is to protect the public. The Enforcement Division strives to conduct fair and impartial investigations seeking only to determine the truth of what happened in each circumstance that gave rise to a complaint and to prosecute only when there is a risk to public health, safety or welfare. The focus of prosecution and discipline against a licensee is remediation to ensure safety and fitness to practice in their profession.

#### **Enforcement Unit FY25 Summary**

During FY25, the Enforcement Division received over 900 complaints. The division resolved over 1,000 complaint cases, including the following:

- Approximately 370 complaints were screened out and/or referred to other agencies for reasons such as: the respondent was not a licensee; the complaint was anonymous and did not provide adequate information; the profession is not regulated by OPR; or the complaint did not allege facts that would constitute unprofessional conduct;
- Investigators completed over 600 investigations;
- Prosecutors closed approximately 430 complaint cases after investigation and I-Team review; and
- Prosecutors filed charges in approximately 180 cases; and
- Disciplinary sanctions were ordered in approximately 160 cases.

#### **Investigation Unit**

The Investigation Unit now consists of six full-time law enforcement investigators, as well as three full-time civil investigators. The role of the Investigation Unit is to conduct thorough, impartial investigations to assist the Prosecution Unit with determining if a licensee engaged in unprofessional conduct. The majority of complaints handled by the Enforcement Division are regulatory (civil) in nature; however, some investigations are criminal and result in the arrest and criminal prosecution of licensees in State and federal court. Approximately ten percent of OPR complaints have some sort of

criminal conduct component. In FY25, there were fifty-eight (58) incidents which were identified as having criminal involvement. Of those fifty-eight incidents, nine (9) individuals licensed by OPR were arrested and criminally charged in State court as the result of OPR investigations.

OPR Investigators often travel throughout the State to: conduct in-person interviews of licensees and witnesses; collect necessary documents; and locate and review physical evidence. Investigators use a variety of methods to gather sufficient information for the determination of whether a licensee has engaged in unprofessional conduct.

During FY25 the Chief Investigator, Michael Warren, was chosen to fill the role as interim director for the Office of Professional Regulation from December 2024 through June of 2025. During this time, the Deputy Chief Investigator, Kris Bowdish, filled the role as interim Chief Investigator. While there was one less investigator working on cases during this time, the remaining investigators all stepped up and increased their workload to help prevent a significant increase in backlogged complaints.

In FY25, the Investigation Unit has continued to see an increase in the seriousness and complexity of the violations alleged in complaints. These complex investigations often required multiple investigators along with assistance from outside agencies including the United States Attorney's Office, The US Food and Drug Administration (FDA), Drug Enforcement Administration (DEA), Vermont Adult Protective Services (APS), Vermont State Police, Local Police Departments, and others.

OPR Investigators have independently, and as a group, worked hard to increase their collaboration with outside agencies. An MOU with MFRAU signed in June of 2024 has streamlined communication between the agencies and joint investigations have resulted in more timely regulatory action by OPR when appropriate. OPR Investigators have also begun working more closely with Investigators from the Agency of Education (AOE) as there are many education employees licensed by both OPR and AOE. OPR Investigators have also begun to work more closely with the Department of Corrections (DOC) as there are many professionals who are licensed by OPR, working within the DOC system. These collaborations and joint investigations with AOE and DOC have resulted in more timely regulatory action by OPR when appropriate.

#### **Prosecution Unit**

The Prosecution Unit has four State prosecuting attorneys, two case managers, and one paralegal. In FY25, the Prosecution Unit hired a new Deputy Chief Prosecutor.

When the investigator completes each investigation, an Investigative Team (or "I-Team"), consisting of the investigator, prosecutor, case manager, and a Board Member/Advisor, reviews the investigation and evidence. The I-Team then meets or communicates to discuss whether the

evidence gathered establishes that the licensee engaged in unprofessional conduct, and, if so, whether the licensee should be subject to public prosecution and discipline. If the investigation does not reveal evidence that supports public prosecution for unprofessional conduct, the complaint is then closed with no further action, and the complainant and licensee are notified of the outcome.

If the prosecutor determines the complaint warrants public prosecution based upon the investigation, the prosecutor files a Specification of Charges identifying the alleged conduct of the licensee and the alleged violations of law. If the licensee contests the Charges and files an Answer, a hearing before the Hearing Authority, either a Board of professionals or an Administrative Law Officer, is scheduled. Before the hearing, the parties exchange documents and exhibits and may take depositions. The parties also have the opportunity to negotiate a mutually acceptable resolution, which must be approved by the hearing authority. If the case is not settled and proceeds to a final hearing, the parties present evidence and witness testimony to the Hearing Authority. After hearing, the Hearing Authority issues a written decision which includes factual findings and either a dismissal of the Charges or a determination of unprofessional conduct. If the Board or Administrative Law Officer determines the licensee engaged in unprofessional conduct, the final order sets forth discipline against the licensee, which is published on OPR's website and is a matter of public record. The sanctions resulting from the disciplinary process can range from: a warning, reprimand, suspension, revocation, monetary administrative penalty, coursework, and/or a conditioned license for a period of time with requirements such as supervision, limited practice setting, random drug testing, and employer reports. Upon issuance of the final order, a licensee may appeal the decision. The intermediate appeal is heard by an Administrative Law Officer within OPR. If the licensee appeals the intermediate decision, the final appeal is heard by the Vermont Supreme Court. If the licensee is subject to conditions as the result of the final order, the case manager monitors compliance to ensure requirements are met.

In FY25, the Vermont Board of Pharmacy approved a \$45,000 fine as part of a settlement between the State of Vermont and CVS, a national pharmacy chain and one of Vermont's largest chain pharmacies. The fine resulted from investigation and charges that were filed in response to several CVS pharmacy stores failing to record and/or update patient allergy and health information, at least annually, as required by a Board of Pharmacy Administrative Rule.

Also in FY25, the Vermont Board of Pharmacy approved a \$15,000 fine as part of a settlement between the State of Vermont and AnazaoHealth Corporation, LLC, a compounding pharmacy in Las Vegas, Nevada. The fine resulted from investigation and charges that were filed in response to AnazaoHealth sending compounded testosterone products to vendors in the State of Vermont approximately 50 times in 2023 and 2024 after its license to operate in Vermont had expired.

### **Legislative Updates**

It was a very busy legislative session. The OPR bill was simpler and more streamlined than in recent years, to make space for the many other bills and initiatives we knew would be addressed this session. Bills which did not pass this session will be picked up next year.
