STIPULATION AND CONSENT ORDER

STIPULATION

NOW COME the State of Vermont, through Attorney General William H. Sorrell, and Respondent who stipulate and agree as follows:

1. The Board of Dental Examiners (Board) has jurisdiction to investigate and adjudicate allegations of unprofessional conduct, and approve consent orders pursuant to 3 V.S.A. §§129 and 129a, and 26 V.S.A. §§767 and 809.
2. Respondent, Janet LaGreca, of Shelburne, Vermont, is an applicant for a dental assistant license by the State of Vermont.
3. Respondent applied for registration in February of 2002. To date, she has not been registered.
4. Respondent admits that on or about February 4, 2002 through August 23, 2002, she performed professional responsibilities as a dental assistant. At that time Respondent was not registered with the State of Vermont, Board of Dental Examiners as required by Rule 2.1
5. Respondent admits the conclusions of unprofessional conduct as set forth below in the Board's Order.

6. Respondent understands that the Board must review and accept the terms of the Consent Order. If the Board rejects any portion, the entire Stipulation and Consent Order shall be null and void.
7. Respondent has read and reviewed this entire document and agrees that it contains the entire agreement between the parties.
8. Respondent voluntarily enters this agreement after the opportunity to consult with legal counsel and is not being coerced by anyone into signing this Stipulation and Consent Order.
9. Respondent voluntarily waives the right to charges and a contested hearing before the Board.
10. Respondent specifically waives any claims that any disclosures made to the full Board during its review of this agreement have prejudiced his rights to a fair and impartial hearing in future hearings if this agreement is not accepted by the Board.
11. Respondent agrees that the Board may enter the order set forth below.

ORDER

Based on the stipulation above it is **ORDERED AND ADJUDGED** as follows:

- A. By engaging in the conduct described in paragraphs 3 through 6 above, Respondent has engaged in unprofessional conduct pursuant to 3 V.S.A. §129a(a)(3) and Board Rule 2.1.
- B. Respondent Janet LaGreca is hereby **REPRIMANDED** and she is assess an administrative penalty in the amount of \$250.00.

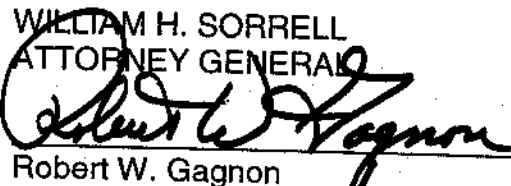
- C. This Stipulation and Consent Order is a matter of public record and may be reported to other licensing authorities as provided in 3 V.S.A. §129(a)(7).

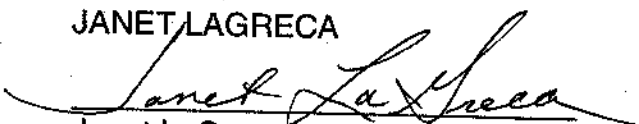

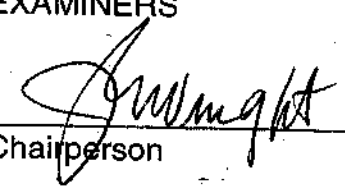
