Pre-Charge Stipulation and Consent Order

The matter captioned above arises from an internal complaint made to the Office of Professional Regulation. The parties to the case hereby agree to an expedited resolution of the matter as follows:

Stipulated Facts and Violations

1. Shelby Sheridan ("Respondent") of Enosburg Falls, Vermont was licensed as a Licensed Nursing Assistant ("LNA") under license number 075.0137488. The State of Vermont first issued this license on June 23, 2021, and the license expired on November 30, 2024.
2. On February 1, 2021, Respondent was convicted of criminal damage, a misdemeanor, in Arizona.
3. On November 29, 2022, Respondent applied for an LNA license. Under the pains and penalties of perjury, Respondent answered no to the question of whether she had any criminal convictions.
4. This act constitutes grounds for discipline because Respondent committed unprofessional conduct in violation of 3 V.S.A. § 129a(a)(1) (Fraudulent or deceptive procurement or use of a license).

Understandings

5. Respondent admits the facts above are true and the conditions below are necessary to protect the public.
6. Respondent understands that this Pre-Charge Stipulation and Consent Order will be reviewed and the Board may accept or reject the Order set forth below. If the Board rejects all or any portion of the Order, then this entire document shall be null and void.
7. Respondent specifically waives any claim that any disclosures made to the Board during its review of this agreement prejudice Respondent's right to a fair and impartial hearing if this agreement is not accepted and proceeds to a merits hearing before the same Board.
8. Respondent has read this document fully and agrees it contains the entire agreement between the parties.

9. This Pre-Charge Stipulation and Consent Order is entered into voluntarily by Respondent after the opportunity to consult with legal counsel. Respondent has not been coerced by anyone into signing this Pre-Charge Stipulation and Consent Order.
10. Respondent voluntarily waives the right to a contested hearing and waives any right to appeal this Pre-Charge Stipulation and Consent Order.
11. Respondent is of sound mind and is not under the influence of drugs or alcohol when signing this Pre-Charge Stipulation and Consent Order.
12. Respondent agrees the Order set forth below may be entered, will be a binding Order upon Respondent, and will be made public.
13. Respondent understands that Respondent is responsible for all compliance costs associated with this Pre-Charge Stipulation and Consent Order and any violation of this Order may result in additional disciplinary action.

ORDER

Based upon the above stipulation, it is **ORDERED AND ADJUDGED** as follows:

- A. The Board of Nursing hereby **WARNS** Respondent's license.
- B. Respondents shall pay an **ADMINISTRATIVE PENALTY** in the amount of \$250.00. This Penalty shall be paid within six months of the date of entry of this Order.
- C. Notwithstanding any provision above, Respondent must continue to meet all requirements to maintain licensure, for license renewal, and for license reinstatement.
- D. This Pre-Charge Stipulation and Consent Order is a matter of public record and may be reported to other licensing authorities as provided in 3 V.S.A. § 129(a).
- E. This Pre-Charge Stipulation and Consent Order will remain part of Respondent's licensing file and may be considered relative to any future disciplinary matter.
