Pre-Charge Stipulation and Consent Order

The matter captioned above arises from complaints made to the Office of Professional Regulation. The parties to the case hereby agree to an expedited resolution of the matter as follows:

Stipulated Facts and Violations

1. Jaime Goldsmith ("Respondent") of Brattleboro, Vermont is licensed as a Tattooist Operator by the State of Vermont under license number 021.0088308. The State of Vermont first issued this license on July 30, 2012, and the license expires on September 30, 2026.
2. Respondent previously operated a licensed tattoo shop called Miss Mayhem's Tattoos under license number 105.0094007. The State of Vermont licensed this shop from April 16, 2013 to September 30, 2014.
3. On or about February 10, 2024, Respondent posted on her Facebook page, which is titled "Miss Mayhem's Tattoo," that, "We are back up and running full steam ahead...though we are not currently in a shop, we are still licensed and ready for your inking needs!!! If you need work done, feel free to hit us up or schedule an appointment!!!!"
4. On or about November 25, 2024, Respondent acknowledged to an OPR investigator that she was tattooing out of her home, which is not a licensed shop.
5. These acts constitute grounds for discipline because Respondent committed unprofessional conduct in violation of 26 V.S.A. § 4105(d)(3) (The practice of tattooing or body piercing shall be permitted only in registered shops).

Understandings

6. Respondent admits the facts above are true and the conditions below are necessary to protect the public.
7. Respondent understands that this Pre-charge Stipulation and Consent Order will be reviewed and the Administrative Law Officer (ALO) may accept or reject the Order set forth below. If the ALO rejects all or any portion of the Order, then this entire document shall be null and void.
8. Respondent specifically waives any claim that any disclosures made to the ALO during its review of this agreement prejudice Respondent's right to a fair and

impartial hearing if this agreement is not accepted and proceeds to a merits hearing before the same ALO.

9. Respondent has read this document fully and agrees it contains the entire agreement between the parties.
10. This Pre-charge Stipulation and Consent Order is entered into voluntarily by Respondent after the opportunity to consult with legal counsel. Respondent has not been coerced by anyone into signing this Pre-charge Stipulation and Consent Order.
11. Respondent voluntarily waives the right to a contested hearing and waives any right to appeal this Pre-charge Stipulation and Consent Order.
12. Respondent is of sound mind and is not under the influence of drugs or alcohol when signing this Pre-charge Stipulation and Consent Order.
13. Respondent agrees the Order set forth below may be entered, will be a binding Order upon Respondent, and will be made public.
14. Respondent understands that Respondent is responsible for all compliance costs associated with this Pre-charge Stipulation and Consent Order and any violation of this Order may result in additional action.

ORDER

Based upon the above stipulation, it is **ORDERED AND ADJUDGED** as follows:

- A. Respondent's license is hereby **WARNED**.
- B. Respondent shall pay an **ADMINISTRATIVE PENALTY** OF \$500 within 6 months of entry of this Order.
- C. Respondent agrees to cease practicing in an unlicensed shop and will henceforth only practice in a licensed shop.
- D. Notwithstanding any provision above, Respondent must continue to meet all requirements to maintain licensure, for license renewal, and for license reinstatement.
- E. This Pre-Charge Stipulation and Consent Order is a matter of public record and may be reported to other licensing authorities as provided in 3 V.S.A. § 129(a).
- F. This Pre-Charge Stipulation and Consent Order will remain part of Respondent's licensing file and may be considered relative to any future disciplinary matter.


