

Foreign Credentialing: Table of Applicable Professions

The <u>Foreign Credentialing Rule</u> provides a process for applicants, who obtained qualifications for their profession in a country or jurisdiction other than the United States, to provide an evaluation and equivalency determination to the Office as part of their application for professional licensure in Vermont. The following table indicates which professions the Foreign Credentialing Rule is applicable.
