CHIROPRACTOR Application Instructions

To obtain competency endorsement for ionizing radiation privileges, please review the information on the Radiologic Technology page at https://sos.vermont.gov/radiologic-technology/forms-instructions/

EXAMINATION:

- Submit an online application and pay the non-refundable application fee. Applications are found within the online licensing system at:
 https://secure.professionals.vermont.gov/prweb/PRServlet/app/default/ybVBleIGIHMIPa8qpM9BaiN

- 2. Request official transcripts or Verification of Education form be sent to the Office <u>directly from the institution</u> by US mail or email to SOS.OPRLicensing3@vermont.gov. If the school provides you with your transcript, it will only be accepted if they are in a sealed envelope from the school.
- 3. Request the National Board of Chiropractic Examiners scores be sent directly to the Office from NBCE.
- 4. Applicants must complete and upload the examination on the Vermont laws and rules governing the practice of Chiropractic. This is found within the online application.

ENDORSEMENT:

To qualify to be licensed, an applicant must be licensed or certified in good standing in another jurisdiction in which the standards and qualifications required for regulation in that jurisdiction are substantially equivalent to Vermont's.

- Submit an online application and pay the non-refundable application fee. Applications are found within the online licensing system at:

- 2. Request official transcripts or Verification of Education form be sent to the Office <u>directly from the institution</u> by US mail or email to SOS.OPRLicensing3@vermont.gov. If the school provides you with your transcript, it will only be accepted if they are in a sealed envelope from the school.
- 3. Request an official verification of license be sent to OPR for your initial state of licensure and most recent state of licensure. This must be sent <u>directly</u> from the licensing authority and can be sent by email to <u>SOS.OPRLicensing3@vermont.gov</u> or by post office mail. It is not required that the other state complete the Vermont verification form.
- 4. Applicants must complete and upload the examination on the Vermont laws and rules governing the practice of Chiropractic. This is found within the online application.

Provisional Licensure

If you are otherwise qualified for licensure <u>and</u> verification of licensure is the ONLY outstanding deficiency and all other licensing requirements are met including applicable education and exam requirements, you may be issued a 90-day provisional license while the Office awaits receipt of your license verification. If you wish to request a provisional license (if applicable), please indicate within the application.

FAST TRACK ENDORSEMENT:

To qualify to be licensed, an applicant must be actively licensed or certified in good standing in another jurisdiction for three or more years preceding this application.

- Submit an online application and pay the non-refundable application fee. Applications are found within the online licensing system at:

- 2. Request an official verification of license be sent directly to the Office. Verification must show proof of continuous licensure in good standing for 3 years preceding the date of this application This must be sent <u>directly</u> from the licensing authority and can be sent by email to <u>SOS.OPRLicensing3@vermont.gov</u> or by post office mail. It is not required that the other state complete the Vermont verification form.
- 3. If applicable, complete and upload the specific VT State Jurisprudence exam answer sheet. This is found within the online application.

Provisional Licensure

If you are otherwise qualified for licensure **and** verification of licensure is the ONLY outstanding deficiency and all other licensing requirements are met including applicable education and exam requirements, you may be issued a 90-day provisional license while the Office awaits receipt of your license verification. If you wish to request a provisional license (if applicable), please indicate within the application.

NOTE: Any change of address or other contract information, by an applicant or licensee, <u>must</u> be forwarded to this office no later than thirty (30) days after change occurs.
