

### **Approved Continuing Education Courses for Vermont Notaries Public**

On October 27<sup>th</sup>, 2022, an <u>email communication</u> was sent to Vermont commissioned notaries public about the upcoming continuing education requirement. Additional information is provided below.

### **RENEWAL APPLICATION**

### **REQUIREMENT**

Notaries who were **initially commissioned** with OPR <u>on or before</u> February 1, 2021, and not otherwise exempt are required to complete the continuing education requirement. The effective date on your commission is not the initial date of your commission.

#### **APPROVED COURSES**

If you are required to complete the CE, you must register directly with the course provider. The completion certificate comes directly from the provider. You will need your course completion certificates to complete the renewal.

Please contact the course provider, not OPR, regarding your CE course registration or completion certificate.

Approved courses that meet this requirement are listed below. Additional providers are working to have courses approved. Check back frequently.

#### 1. Vermont Bar Association

OPR will accept coursework that complies with the following guidelines even if not approved by OPR and found on one of the links provided above:

- The content of the course must be related to the maintenance and enhancement of the skill, knowledge, and competency to perform notarial acts in accordance with Vermont's laws and requirements.
- The course can be synchronous or asynchronous, recorded or live, inperson or remote.
- The course must contain both audio and visual content.
