Entergy Nuclear Operations, Inc. operates the Vermont Yankee (VY) Independent Spent Fuel Storage Installation in accordance with the general license provisions of 10 CFR 72. The conditions of 10 CFR 72.212 require the registration of a spent fuel cask within 30 days of using a cask for storage of spent nuclear fuel. The fuel contained in the cask is from the VY Nuclear Power Station.
